# Why do Nazis get clubhouse? Supervisors ask

The Board of Supervisors has asked the Recreation and Park Commission to explain why it lets Nazi groups use the Wawona Clubhouse, near Wawona Street and 19th Avenue.

Supervisor Quentin Kopp said he was appalled to discover the National Socialist White Workers Party have used the facilities over the last two years.

Kopp directed a letter to City Attorney George Agnost, asking if The City could deny use of its facilities to such groups. He suggested, "If necessary, we take it to the highest court in the nation."

Kopp and Supervisors Harvey Milk, Ella Hutch, Robert Gonzales and Dan White asked for replies within the week.

Even if a black shows up at a Nazi meeting with an invitation and is barred at the door, the Nazis' action would be protected by constitutional guarantees of freedom of assembly and freedom of association in Delventhal's opinion.

Kopp termed the groups "obnoxious" and declared they "have as their purpose and intent the desire to disturb the peace and to create incidents for violence."

He said, "I think they are a clear and present danger to the tranquility of our city."

In an invitation to a March 4 meeting at Wawona clubhouse, a copy of which was obtained by The Chronicle, National Socialist White Worker's Party leader Allen Vincent billed the event as an "open-

THE JEWISH MEDIA

When Rabbi Siegel made the statement that the "Jewish vote" put Carter in office, many people wondered how a minority group could swing this. The Jews comprise less than 5½% of our total population of 220 million. What Siegel meant was the JEWS control the vote.

With Financial backing the Jews control the minority block vote in big cities. By this backing, the Jews tell their candidates how to vote and for whom. The Jews promote and give them exposure on their controlled TV. And the Jews are tied in with Mafia circles in New York and some Labor unions.

They control 85% of the world press, the wire services and 100% of our major TV networks; most magazine chains, publishing firms and major newspapers. They can, at will, canonize or demonize any politician. The politicians know this, particularly after what happened to Nixon and Agnew, whom the Jew detested.

The Jewish controlled television publicized "Watergate" to the extent the trial of the Nixon Administration was a conviction in the public eye. Richard Nixon had no more chance of a fair trial than the defendants at Nuernberg! I'll go into that in another issue of the STORMER. I would like to explain what's happening to Carter.

Carter tried to be fair with the Arabs and was immediately pounced upon and threatened. He accommodated the Jews by appointing many Jews to his Cabinet. Carter wanted his friend, Bert Lance, who is not Jewish, to be Budget Director.

Lance's banking practices are not uncommon in small Southern towns and nobody gets hurt. However, the Jewish Lobby was aware of this when they confirmed Lance's appointment. When Lance refused to support and cater to Begin's actions in Israel, the Jews suddenly got their controlled MEDIA to lower the boom on him. Then Javits and Ribicoff and their stooges put the pressure on. Lance was forced to resign to avoid another "WATERGATE."

# Nazi leader files rights suit



Allen Vincent's suit accuses a variety of city officials

The local Nazi leader has filed suit in federal court here, seeking \$28 million from individuals he said deprived him of his constitutional rights following a mob attack on the tiny party's bookstore in the Outer Sunset.

Among those named by Nazi leader Allen Vincent are Morris and Allan Weiss, a father and son who were arrested after the incident at the Rudolph Hess Bookstore at 3608 Taraval St. on April 1. Charges were dropped "because of substantial evidentiary problems and in the interests of justice," District Attorney Joseph Freitas said at the time.

"On that day in San Francisco,

justice died and nobody opened their mouth," Vincent told reporters yesterday.

Two months after the incident, Assistant U.S. Attorney David Bancroft said no federal charges would be filed because "applicable federal statutes do not cover the alleged misconduct." Bancroft is also a defendant in Vincent's suit.

Other defendants include Freitas; Supervisor Dianne Feinstein; Mayor Moscone; Rodney Williams, whom Vincent described as "the so-called black police officer who was placed in charge of the so-called investigation"; Examiner Managing Editor Dave Halvorsen and Examin-

er editorial writer Jack Castel, among others.

Vincent said the Examiner people were named because "they are writing all kinds of crazy articles, saying bad things about me, putting me in the garbage can."

Asked about his group's use of the city-owned Wawona Clubhouse at Stern Grove, which was questioned earlier this week by Supervisor Quentin Kopp and others, Vincent said:

"Kopp is always shooting his mouth off. —Stern Grove is a public place. We've been meeting there for months."

# LITTLE KNOWN FACTS

## Gen. Ike Helped To Cover Up The Katyn Horror

General Eisenhower was a party to the suppression of the truth about Russia's massacre of 15,000 Polish officers in Katyn Forest during the first year of World War II.

At the time of the Nuremberg Trials, in 1945, when Ike was still the Allied Commander in Europe, he was visited by representatives of the Polish anti-Communist government-in-exile in London and asked to assist the Poles in getting the truth about Katyn into the Nuremberg proceedings.

General Ike declined to aid the Poles. At the time, his attitude was that the less said about Katyn, the better.

Representative Thaddeus M. Machrowicz (D. Mich.), who revealed the curious Eisenhower role on the basis of information furnished him by top Polish anti-Communists, declared that "Eisenhower just didn't want to tangle with the Russians."

"And that was at a time we weren't playing footsie with the Russians anymore," Machrowicz added.

The failure to publish the truth about Russian atrocities in 1945, at the Nuremberg trials, gave the world a distorted and misleading picture of Russian good will during the early post-war period.

The mistaken picture of the Russians had much to do with the willingness of the United States to demobilize after V-J Day—a course which later came to be recognized as the cause of America's 'cold war' predicament.

Im maintaining cautious silence about this atrocity in 1945, General Ike seriously damaged our country's position in subsequent international developments. (from "Headlines" issue of June 25, 1952)

## JDL, Nazis Clash Outside Academy Award Rites

### Police Declare Tactical Alert After Violence Erupts Near Music Center; Three Persons Arrested

A police tactical alert was declared Monday night outside the Academy Awards ceremonies at the Music Center when demonstrators from the Jewish Defense League clashed with several men wearing Nazi uniforms.

Forty extra policemen from 10 divisions throughout the city were rushed to the scene after two of the purported Nazis were knocked to the pavement and three JDL members were arrested on suspicion of assault.

Two men, Richard Rogers, 40, and Herbert Booker, 36, were taken by ambulance to Queen of Angels Hospital. One had a bruise on his cheek.

The violence occurred as several hundred members of the JDL and the Palestine Arab Fund and a small Nazi contingent demonstrated over Vanessa Redgrave, a nominee at the ceremonies for best supporting actress.

The demonstration took place in front of the Department of Water and Power Building, across the street from the Music Center at 1st and Hope Sts., as celebrities arrived for the awards ceremonies.

Miss Redgrave is under fire by Jewish groups for financing and narrating a film called "The Palestinian," which contains an interview with PLO leader Yasser Arafat and reportedly is anti-Zionist in tone and advocates the overthrow of Israel.

Richard Rogers, 40, of Culver City and Herbert Booker, 36, of Los Angeles were treated at Queen of Angels Hospital for their injuries. Police said Rogers had head and eye injuries and Booker suffered a possible broken nose.

Painted the words, "Vanessa Is a Murderer."

JDL members shouted "Hell no, PLO" and "Never Again."

The Arab group marched under a Palestinian flag and carried placards reading "Zionism Is Racism" and "Palestinians Have Human Rights, Too."

A spokesman for the Arab group, estimated at about 200 persons, said his group was not conducting a counter-demonstration but was supporting Miss Redgrave.

The JDL contingent was put at about 125 persons.

Perons in bleachers in front of the Music Center cheered arriving cele-

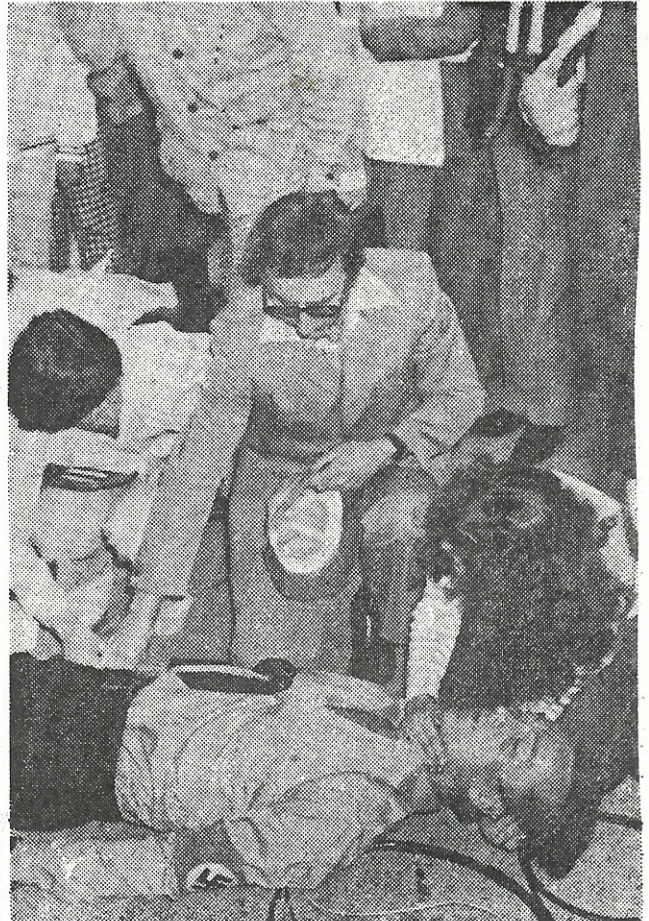
Police said two JDL members were booked for suspicion of assault with a deadly weapon on a peace officer when they allegedly turned on a policeman who was trying to break up the fight with the Nazis.

They were identified as Barry Krugel, 35, of Granada Hills and Muriel Moorehead. Police said Krugel was booked at Parker Center and Miss Moorehead at Sybil Brand Institute.

In connection with the same incident, Earl Krugel, 35, of Van Nuys, the twin brother of Barry Krugel, was booked for allegedly inciting a riot.

In a separate incident in the same area, Michael Webber, 24, of Buena Park was booked on suspicion of violating a city ordinance against burning someone in effigy. He allegedly set fire to a dummy representing an Arab.

JDL leader Irv Rubin who led the Jewish protesters, was arrested earlier in the day and booked for investigation of soliciting murder, mayhem or bodily injury, police said.

At a news conference last month, Rubin allegedly offered a \$500 reward to anyone who would kill or maim a Nazi party member. He also allegedly offered \$500 to anyone who could bring him a Nazi's ears — presumably detached from the Nazi's head.

# PERSECUTION ANYONE?

**ROME (AP)** — Convicted Nazi mass murderer Herbert Kappler, 70, wasting with cancer and wanting to go home to die, escaped from a military hospital yesterday, apparently stuffed into a large suitcase and dragged out by his wife, officials reported.

A West German government spokesman said in Bonn that Kappler's wife later called authorities and said her husband was in West Germany, but his exact whereabouts were not known.

West German federal police said they were searching for the ex-Gestapo official at the request of Interpol, the international law-enforcement clearing house.

The Italian news agency ANSA said Italy had asked its ambassador in Bonn to seek Kappler's extradition.

About 40 persons, including some Jews, demonstrated outside the Celio

military hospital later yesterday. One scrawled on a hospital wall, "Kappler has escaped ... Who are the accomplices?"

Kappler was serving a life sentence for ordering the execution of 335 Italian civilians, including 70 Jews, in German-occupied Rome in 1944 in reprisal for the killing of 32 Nazi soldiers. He had been hospitalized for the past several months for treatment of his illness, reportedly stomach cancer.

Italian Defense Minister Vito Lattanzio told a news conference the bizarre escape was possible because cancer had emaciated Kappler to 105 pounds.

Lattanzio said three military policemen guarding the corridor of the hospital reported that Kappler's German wife of five years, Anneliese Kappler-Wenger, 54, made a regular visit to her husband's private fourth-floor room Sunday night.

On leaving at about 1 a.m., she posted a note on the door reading, "Do not disturb until 10 o'clock," and dragged the loaded suitcase down the corridor to an elevator, took it

downstairs and placed it in the trunk of a red Fiat she had left in the hospital parking lot last Friday, Lattanzio said. She then drove away.

As Rome commander of the Gestapo, the Nazi secret police, Kappler ordered the shooting of 335 Romans in the Ardeatine Caves near the catacombs in southern Rome on March 24, 1944.



## Bomb rips office in Nazi reprisal

MILAN, Italy (UPI) — A terrorist bomb exploded outside the offices of the Italy-Germany Chamber of Commerce early today in apparent reprisal for the escape of Nazi war criminal Herbert Kappler.

No one was injured in the explosion, which heavily damaged the Chamber of Commerce offices, shattered windows in two nearby hotels and damaged three cars and a tourist bus.

Kappler, who supervised the shooting of 335 Italian hostages during World War II, was smuggled out of a Rome military hospital Aug. 15 by his wife Anneliese.

## The Suitcase Nazi

When the wife of a 70-year-old German cancer victim took her husband out of the hospital last August so that he could die in his own home, her action caused an international stir. The patient was former SS Col. **Herbert Kappler**, a Nazi war criminal serving out a life sentence in a Rome military hospital for the massacre of 335 Italian civilians at the Ardeatine Caves, and his 52-year-old wife, Anneliese, (whom he had married in prison), spirited him back to Germany by cramming his frail, 105-pound body into a suitcase and lugging it past the guards to her waiting Fiat.

The Italian Government drew criticism as having—inadvertently or not—paved the way for the escape by not providing adequate security, and then Prime Minister Giulio Andreotti asked the West Germans to send Kappler back. Germany said no, at least for the time being, and relations between the two normally friendly countries came under severe strain. Now that the dust has settled, however, everyone seems content to let the matter rest.

**Police Protection:** Kappler is now living in an apartment above the homeopathic clinic that his wife operates in Soltau, a city south of Hamburg. The blinds are kept drawn both day and night and two plainclothes policemen stand constant guard outside to protect Kappler from threatened reprisals on the part of Italian leftist groups. Thinner by 10 pounds than when he escaped, he is described by his wife as bedridden and “very, very

wretched.” She won’t let him read the newspapers or watch TV, since she thinks coverage of his case might upset him. Kappler had refused both surgery and chemotherapy for his intestinal cancer while in Italy, but is now undergoing his wife’s “natural” cancer treatment, which includes herbal tonics and loving care. He took a turn for the worse during the Christmas holidays, Fran Kappler says, and could die “right under my hands any day, any hour.”

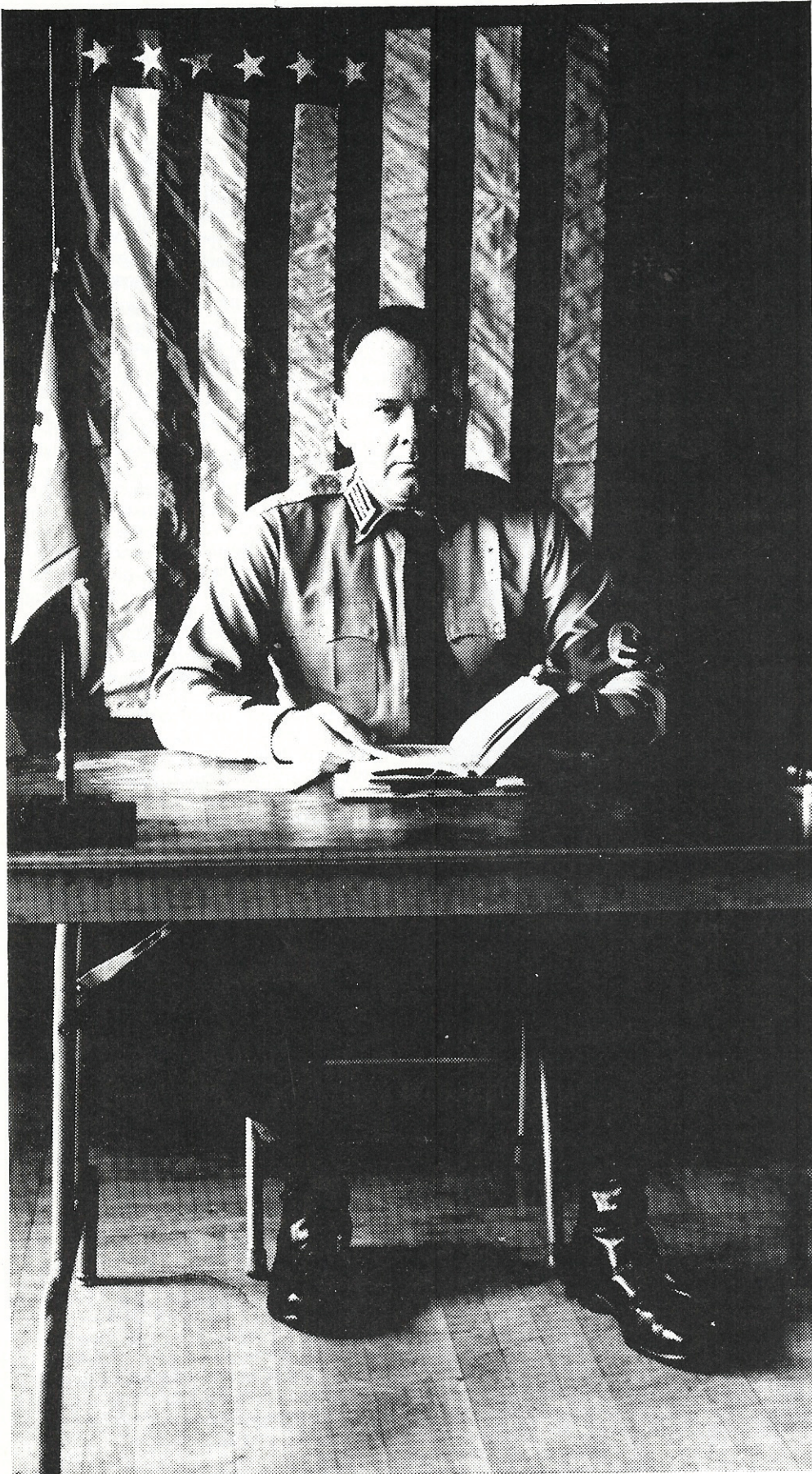
An Italian military tribunal is winding up a five-month investigation of the escape. The three *carabinieri* stationed outside the prisoner’s hospital room (one of whom helped Kappler’s wife carry the heavy suitcase to the elevator) have already been cleared of negligence, and informed sources don’t expect the tribunal’s findings to deal harshly with any government officials. Even the man who became the scapegoat of the affair has landed on his feet. Though Defense Minister Vito Tanzi was pressured by the Communist, Socialist, Republican and Proletarian Democratic parties to give up his Cabinet post, he wound up exchanging it for two others: Minister of Transportation and of the Merchant Marine.

**No Extradition:** A scheduled summit meeting between Andreotti and West German Chancellor Helmut Schmidt was postponed indefinitely after the Kappler incident, but finally took place in Verona, Italy, last month; afterward, Andreotti reported that relations with West Germany are excellent once again. But despite Chancellor Schmidt’s recent assurances to the Italians that “the sympathy for an old, sick man like Kappler will never be greater than our sympathy for the relatives of Kappler’s victims,” the German Government refuses to extradite him. The Germans base their decision on Article 16 of their postwar constitution, which prevents the extradition of any German national—even though some legal experts maintain that it doesn’t apply to crimes committed before the constitution was adopted. At any rate, German public opinion is solidly behind Kappler: of those who expressed an opinion in a nationwide poll taken last October, fully 77 per cent said they welcomed his return.

The Kappler case isn’t closed yet. Italy submitted reams of prison files and wartime documents to the German Government, which has delegated to the regional attorney general’s office the task of deciding whether Kappler should be retried in Germany. Although no decision is expected for several weeks, such a move is considered highly unlikely. Still, the specter of Kappler being packed off to jail haunts his wife. “This will only happen over my dead body,” she says. “Over my dead body. They shall not do it!”

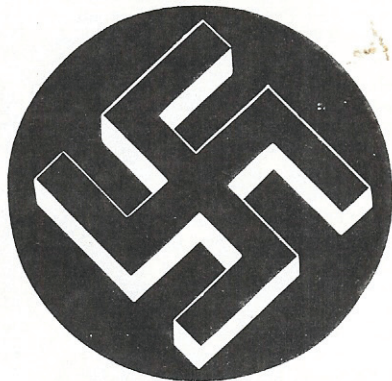

Rockwell, the party founder, was killed by an associate in 1967, and Joe Tomasi, a West Coast Nazi leader, was shot dead two years ago following a party dispute.

Three Nazi groups now predominate. One is the National Socialist White People's Party of Arlington, Va., led by Matt Koehl. Another is the National Socialist White Worker's Party of Allen Vincent in San Francisco. The third faction is the Chicago-based National Socialist Party of America, headed by Frank Collin. Efforts are being made to unite these groups with extremist organizations such as the Ku Klux Klan.

Collin is regarded by Jewish groups as the most effective Nazi spokesman—a role that seems incongruous to many of his opponents. According to published reports, his family name was changed to Collin from Cohn. During World War II, his Jewish father was imprisoned in the concentration camp at Dachau.

In many areas, American Nazis have tried to "legitimatize" their movement

# Fourth Reich in California

I entered the room.

"This place will be hallowed ground some day. It will be a sacred shrine in the New Nation, the Nation to come."

The words struck at me, and were gone. I looked to see who had said them. No one was near—yet so near had they sounded. Phantom words? I looked all around the room. Phantom words in a phantom place.

I was in a large meeting-hall of unique interior design. Thick glistening beams traversed the ceiling and slid down the paneled walls at uniform intervals. Across the wooden floor and built into the center of the far wall were three throne-like oaken chairs, apparently sculptured with meticulous care—high, pointed backs, studded arm grips, simple, powerful, in design. Norse Gods could have sat there and felt at home. The thrones were on a raised platform, and in front was a speaker's lectern. Flanking the lectern were two immobile wooden desks, and flanking those, two battered upright pianos. The place could have been a Munich beer-hall of the 1930s.

It wasn't, of course. It was "Odin Hall" at the Swedish-

decorations in the room gave a good idea of what the meeting that particular day was about.

Pinned to one wall was a huge red, white, and black swastika banner. The hooked cross at the center of the white circle seemed to leap out at you, or anyway stare you in the face. Similar, slightly smaller, banners were draped all over the room, as well as on the fronts of the two desks. In back of the right desk was a 3' x 5' American flag. Hung in the place of honor just above the center throne was a heroic-sized portrait of Adolf Hitler.

In the far left corner of the room stood a beautiful Christmas tree. Two pretty teenage girls in uniforms of black skirt, white blouse, red bandana, and swastika armband were decorating the tree with tinsel and blubs. All across the left wall folding tables had been set up. Near me by the entrance hung a silver and black "SS" banner. A record player was blaring forth stirring martial music.

Then two dozen Stormtroopers, in the classic uniform, — black boots, brown shirts, black ties, shoulder straps, and armbands, — filed in the entrance past me

and began greeting people, setting up chairs, and helping with the decorations.

What did surprise me was that I came. Disdain, and even fear, had been overcome by tremendous curiosity. So there I was, feeling out of place without a swastika armband.

It was getting near to meeting time, and the hall was filling up with people. I began to walk through the room, and mingle and observe, with the intent of finding an answer to the question, "Who would attend a Nazi meeting?"

In truth I had already made up my answer before I came. Fanatics would be there. Fanatics, glassy eyed and sweating, screaming about RACE PURITY, and fomenting against the Jews, saying how they should all be exterminated, etc.

But I found none of these.

Instead, I saw all kinds, people that might just as well have been at a Rotary Club gathering, or a New England town meeting. It was a picture out of Middle America. Women and girls bustling about, setting up the foods and refreshments for the Christmas Party and social period after the meeting. A man of about sixty years in an American Legion cap, his vest decorated with U.S. Army campaign ribbons of World War II. Man in business suits. Men in work outfits. Little boys and girls, obviously the offspring of some of the adults there. Young people my age. All talking, laughing, greeting each other, and slowly, almost imperceptibly, moving over to where the folding chairs were set up, where the meeting was shortly to begin. Many of the people wore armbands over their regular clothes. Others, first-timers like myself, did not. You could spot the newcomers. They would sit down by themselves and look self-conscious, or walk around and listen in on discussions, or read silently the Party publications and leaflets that were available at the literature table.

I went over to the literature table. On it were copies of the Nazi newspaper, *White Power*, swastika stickers with provocative slogans (*Hitler was Right, Communism is Jewish, Free Rudolph Hess*), posters, and assorted pamphlets. Also there was a copy of the San Francisco Examiner in which the Nazis had been given front page publicity for protesting a Jewish fundraising affair. I glanced through some of the items, and then took a seat at the back of the hall.

Most of the people (I estimated their number at 75) were now sitting down. The Stormtroopers were lined up in formation along the side walls, arms folded across their chests. Suddenly, as if by signal, the last standees sat down and a noticeable hush descended upon the room. The meeting was about to begin.

Someone sat the needle down upon a turning record and a fanfare of trumpets pierced the silence. Northern California Nazi Unit Leader Allen Vincent and two lieutenants entered and strode down the center aisle to the music of a German military march. They stood in front of the three thrones and remained standing even after the music had stopped.

"All National Socialists please rise," intoned Vincent.

Everyone rose, and I didn't want to be a spoil-sport about the whole thing, did I? We faced the large banner and raised our right arms in the familiar salute.

"I pledge allegiance," the chorus began, "to Adolf Hitler, the immortal Leader of our race, and to the New Order for which he stands. One great cause, sacred, and true..."

Pledge over, we sat down and the meeting was called to order.

Allen Vincent moved up to the lectern. He was a big man, heavy set, with a commanding presence.

"I just want to say a few words," he began. "As you all know the growth of our Party this past year has been tremendous. Whoever would have thought, a year ago when we started this thing, when we were lucky to get

maybe ten people together in someone's living room, that it would develop into this. I wish to thank all those who have joined us and supported us these past months. It shows that there are White people in San Francisco who are willing to stand up and fight for their race and nation, their culture and history, their future!" (Much applause).

"But there is no time for congratulations. We must move forward from where we are, and quickly. I don't think I need remind any of you that time is running out for the White Race on this planet. Right now we are outnumbered seven to one. By the year 2000, if present trends continue, it will be fourteen to one. The survival of the Western White Man depends on what we do here in America. If our country is lost to the Jewish racemixers, then the whole world is

lost. It is the historic task of our movement to reawaken and rekindle the spirit of racial idealism in the White people of this land.

The room rocked with applause. Vincent sat down in the center throne and one of the Stormtroopers went to the lectern. He identified himself as a history teacher (in a private school) and said he was going to speak of race-history and the lessons we can learn from it. He told of the ancient Aryans, a fair-haired, blue-eyed, pink-skinned people who migrated from their homeland in Northern India and founded the civilizations of Egypt, Greece, and Rome. The Aryan bore within him the seeds of a superior culture and intellect, a higher form of life, and as long as he remained pure, his civilization flourished. But he did not remain pure. He bred with inferior peoples, with negroids and Mediterranean half-breeds, and lowered the quality of his own Race. The great civilizations withered away. Pure Aryans went to Northern Europe, where they developed our modern Western Civilization, and from where many migrated to the New World. America is still a substantially Aryan nation, and must not fall victim to the curse of race-mixing, which is being pushed by insidious Jews in order to make a mongrel race of us, ripe for total Jewish domination.

"Heil Hitler!" the trooper yelled after finishing his speech, and he walked back to his place to a resounding chorus: "Heil Hitler!"

The next speech was a short one, by another trooper, which stressed that National Socialism is not a "German" idea, but a "White Racial" idea applicable to America. Adolf Hitler was not so much a German nationalist as an Aryan racialist, and his race-saving swastika banner should be picked up by all patriotic Americans.

Finally the last speaker appeared, and his was a more down-to-earth message:

"Many of our City schools are in trouble. 'We've got a discipline problem,' wail the administrators. 'We can't keep order. We've got a morale problem,' etc. Well the truth, pure and simple, is that they've got— a nigger problem! A nigger problem! That's the whole story in a nutshell."

All four verses, including refrains, were sung. No one's outstretched arm wavered a single inch until the last note was sounded.

The lights were turned back on the flames extinguished. With the announcement that \$47.00 had just been raised, the formal meeting was adjourned, and most of the people filed over to the buffet tables, where lay the Christmas feast.

It was literally that. The tables groaned under the weight of Champagne, beer, coffee, punch, potato salad, knockwurst, imported cheeses, nuts, crackers, turkeys, hams, kosher (!) dills, cookies, candies, and, topping it all off, a large cake topped with a frosted swastika.

I opened a bottle of beer. Sweet, heavy, and thick, it was German and cold and very good. A nice looking man approached.

"Are you Swedish?" he asked with an accent.

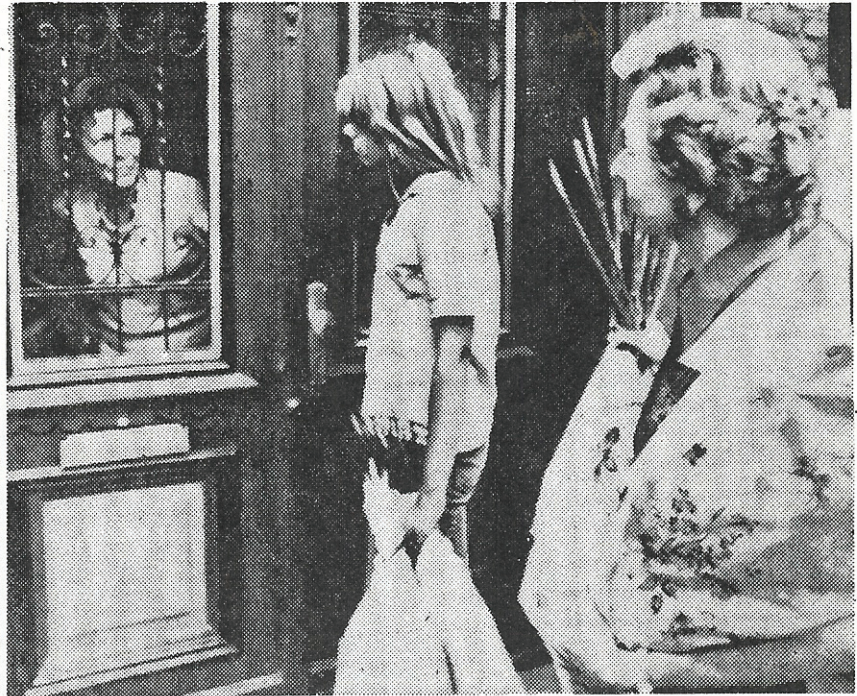

## Detroit Labor Builds Anti-Nazi Coalition

Walking through Detroit's smoky southwest side, one finds shops and restaurants displaying signs in English, Spanish, Arabic and other languages. The neighborhood—not far from the busy Detroit riverfront — is home to thousands of workers of all races and national backgrounds who have made it a vigorous, tightly knit community.

Three months ago, an alien sign appeared on one of the major shopping streets. Members of the tiny National Socialist Movement, one of several Nazi groups in the U.S., had rented an empty storefront and turned it into a bookstore. Outside, the swastika and "White Power" were painted on the wall. Inside, pictures of Adolf Hitler and anti-black and anti-Semitic posters were pasted on the walls. Nazis began distributing literature to nearby schoolchildren, trying to divide the multi-national character of the community.

At first shocked, then angered, the community — which includes many auto workers — picked up the challenge. UAW Local 600, which represents workers at the nearby Rouge complex of the Ford Motor Co., just across the Detroit city limits in Dearborn, voted to join with other unions, civil-rights groups, and community organizations in a coalition to drive out the Nazis.

Skilled-trades workers in UAW Region 1E, especially angered over the Nazis' attempt to sow their hate literature among schoolchildren, joined the fight.

The Labor-Community Coalition Against the Nazis has held two public rallies and has set up 18 committees to help do anti-Nazi educational work in the schools and community. It expects to organize a mass anti-Nazi demonstration in April.

UAW Region 1A Director Robert Battle III, Local 600 President Mike Rinaldi, and Local 157 President Joe Danz are among the individuals on the group's steering committee, which is chaired by Local 600 retiree Paul Boatin.

"Most of the UAW membership hasn't felt the immediate, brutal impact of the Nazi threat," says Danz, who also chairs the Region 1E Skilled Trades Leadership Council, "but we know it's a growing problem that could smack us in the face tomorrow or the next day."

Shortly before *Solidarity's* deadline, the coalition held another organizing meeting at which four Nazis were spotted in the crowd. Ordered to leave, one lashed out with a razor, cutting coalition member Jan Friedman deeply on her left leg. She is recovering, and the anti-Nazi fight goes on. □

## Vacate store, Nazis ordered

Nazi running a controversial bookstore on Detroit's west side were ordered Wednesday by a Detroit Common Pleas judge to get out of the building in 10 days or face eviction.

Judge Henry J. Szymanski gave a directed verdict for eviction after William Russell, spokesman for the Nazi bookstore, made a brief statement and said, "We are not offering no defense at all."

IN THE hearing, landlord Eddy S. Bullock Jr. sought to evict the tenants, who had

aroused strong community opposition. It was held before a six-person jury in a packed courtroom and lasted 5½ hours.

Russell represented himself during the proceedings, saying no Detroit lawyer would defend a Nazi.

At the conclusion of the trial, Russell said that he ex-

pected to lose "from the time (the eviction) notice came."

He said he had no plans to appeal and had not yet determined whether he would open another bookstore someplace else.

## Judge tells Nazis to vacate building or face eviction

court hearing, with rapid-fire argument between the Nazi tenant and his landlord.

Dressed in his blue denim jacket with shirttails swinging, Russell attempted to cross-examine the four witnesses brought forward by the landlord's lawyer, Alan M. Silver.

The one witness that stumped Russell for cross-examination was himself. Silver called on Russell as the final witness for the plaintiff.

"How am I going to ques-

tion myself, your honor?" Russell complained. "Do I say, 'Uh Bill, how old are you?'"

SILVER WAS attempting to prove that Russell broke his lease because he did not operate the store, located at 7608 W. Vernor, as a printing business.

Russell admitted in court that his printing business had no name, that he had applied for no zoning variance for a printing business, that the business had no telephone number, never advertised, never charged sales tax and never charged for its printing jobs — of which he had three.

Landlord Bullock testified that Russell never told him Nazis would be moving in. The owner of a neighboring beauty salon, also rented by Bullock, said she had lost business because of reported demonstrations held to protest the Nazis.

OTHER damaging testimony came from James Johnson, who claimed to be a printer with 29 years' experience. He said that he entered the bookstore with the landlord, who had requested him to fix the plumbing.

After looking in every room and doing some minor repairs on the pipes, Johnson was able to conclude that the Nazis had no presses, no printing paper and no ink.

The Nazi bookstore, which opened on Dec. 17, has been the focus of numerous demonstrations and pickets from a wide variety of community groups, ranging from religious organizations to the NAACP and labor unions.

The latest demonstration came Sunday when 500 persons met at the UAW Local 600 hall at W. Vernor and Dix Highway to decry the bookstore. Two dozen speeches were followed by a 125-car motorcade which drove past the Nazi store with people yelling from their windows and honking horns.

While he had suffered a setback Wednesday Russell appeared undaunted. In a final statement to the press he said, "I worked many hours to build up this building (the bookstore) and I can do it again."

# Nazis store tenants lose eviction trial

Concluding a trial laced with anti-Communist rhetoric and racial slurs, Nazi tenants yesterday were ordered evicted by March 25 from their southwest-side bookstore headquarters, the scene of numerous community and group protests in recent months.

Detroit Common Pleas Judge Henry J. Szymanski issued the notice, while also giving tenant Bill Russell 10 days to appeal the decision or file for a new trial.

There was no indication from Russell or his two Nazi companions whether they would appeal or if or where they would relocate the bookstore.

Russell — acting as his own defense lawyer in the breach-of-lease complaint brought by landlord Eddy S. Bullock Jr. — lost the case not on a constitutional issue or a jury decision, but on a matter of court procedure.

RUSSELL, WHOSE NAME appeared on the lease, declined to offer witnesses or his own testimony to defend his case, after a six-member jury spent most of yesterday listening to witnesses for the landlord.

After Russell said he would offer no defense, Bullock's attorney, Alan Silver, asked the court for a directed verdict — which meant the jury would be dismissed and the judge would make the ruling on a matter of law rather than evidence.

Judge Szymanski said procedure dictated that Russell, as the defendant, had "a burden to go forward with evidence." Because he declined to do so, the judge said, Bullock's evidence was "unrebutted and unopposed" and warranted the eviction order.

Bullock charged in his eviction attempt that Russell breached his lease, deceiving the landlord into thinking he was going to open up a printing business rather than a Nazi propaganda center. They were served with the notice shortly after Dec. 17, when they opened the bookstore in the blue-collar neighborhood.

Russell said he would not bring forth witnesses because pretrial prejudice gave him no chance of winning and that witnesses on his behalf would be open to "Communist" attack and harassment.

During the trial, and when questioned by Silver, Russell often spoke of Communists, saying once he could tell "one of them" was in courtroom because he was wearing a "white shirt and red tie."

Russell said several times during the trial that he knew he would lose the case, once citing "pressures" put on the court by area labor unions. Russell told the judge because of the Nazi group's reputation, he could not get a lawyer.

When Russell referred to the proceedings as a "kangaroo court," it brought a chuckle from the judge.

Russell, 24, self-proclaimed spokesman for the National Socialist Movement in Michigan, wore a blue-jean vest which displayed a swastika and a "White Power" button.

At least half a dozen uniformed and plainclothes police officers were on hand in and near the packed courtroom yesterday.

Witnesses from businesses near the bookstore testified that area stores, including a beauty shop and dry cleaner, were losing business because of the bookstore and frequent protest demonstrations.

Bullock testified that on the day of one of the demonstrations, one of the Nazis hosed down the sidewalk with water, which then turned to ice and made it difficult to walk in the area.

A NEIGHBORHOOD beautician testified that she never saw any printing supplies being delivered or taken from the store, but often saw a number of "children and teen-agers" entering and leaving the bookstore with Nazi propaganda in their hands.

After first taking the stand, Russell refused to give his home address to the court, saying he had to protect his wife and children from Communist attack.

When Silver questioned Russell, seeking to establish he was not in the printing business, he asked him: "You wouldn't print anything for me, would you?"

"No, I told you I wouldn't," Russell responded.

Russell admitted during questioning the printing business had no name, did not do business in public and collected no sales tax. He testified it printed material for affiliated Nazi organizations.

## Fascists In America — A Real Threat Now!

Dear Comrades:

In *Workers' Power* #240, Feb. 6, a statement in the otherwise excellent article "What Is Fascism?" bothered me. It reads:

"Today in this country the economic crisis is not so bad that fascism is likely to flourish and become a real threat in the near future."

I think the statement is misleading. It all depends on what you mean by "real threat."

Now we can certainly agree that the American right wing is 'certainly not' on the verge of taking state power as they did in Germany.

But in the last several years there has been a sharp increase in extreme right wing activity in this country, as noted by the Black press.

Ebony magazine, in their February 1978 article on "Ten Best Cities for Blacks," reports:

"Race relations in Indianapolis are troubled by the continuing activity of the Ku Klux Klan, the John Birch Society and the American Nazi Party."

In Los Angeles, "the city's Black population has limited political clout and is confounded with increasingly assertive Ku Klux Klansmen, John Birchers and American Nazis—a trend noted in many large cities today."

Other cities such as Boston, Louisville, New Orleans, Columbus, Ohio, Houston, Pontiac Michigan and Chicago have been plagued by extreme right-wing inspired racial violence and terror.

In other cities the new-fascist movements have quietly established over 100 branches and headquarters and set about the business of entrenching themselves.

Eighteen months ago I was driven from my home on the

southwest side of Detroit by the local Klan. They threatened our landlord that they would burn down our house if she did not evict the "ulger lovers."

Terrified of what might happen, she evicted us.

It seems to me that it is the duty of socialists to be in the forefront of the anti-fascist struggle. Black, white and brown working class unity can only be achieved if Blacks and Latinos see class conscious whites responding to racist, fascist attacks directed at minorities with the same vigor and militancy as the KKK and Nazis were out to exterminate them and their family.

I think we must all realize that these fascists are a real threat and we must answer them blow for blow now!

## Hateful words merit protection

Words are inadequate to describe most Americans' scorn for and loathing of Nazism. So it is with understandable horror that west side Detroiters have discovered an American Nazi group stationed in their midst.

The group, which has opened headquarters at 7608 West Vernor, is Hitlerism personified. It even gives the smashing of Jews and the deporting of blacks.

The best thing to do about such a racist hate group is to ignore it completely. But the group's hateful appearance in Detroit demands comment.

To begin with, most neo-Nazis have deep psychological problems. They crave attention. They thrive on the outraged reaction they get from people.

A newspaper reporter once asked a motorcycle clubber why he wore a swastika. The reply was

revealing: "Because it freaks people out, man."

Yet the civil liberties question is not so easy to answer. You cannot shut the Nazi headquarters without destroying the First Amendment. As odious as it is to see the recrudescence of Nazism, it is dangerous to curb political expression. It is also unconstitutional to do so.

The real test of a belief in freedom of speech is this: Will you protect the delivery of the speech you hate as well as the speech you love?

Yes is the only possible answer to that question for true believers in the First Amendment.

The News believes that in democracy's marketplace of ideas, Nazism will be a worst-seller. We agree with the pickets who chanted outside the Nazi HQ: "Nazi and Klan are the scum of the land." But we also cherish the right of free expression by everybody — including Nazis.

## Parents near Nazi bookstore lose aid plea

A group of Detroit residents, aroused by a Nazi bookstore in their area, asked the Region 2 School Board this week for additional security guards and for an anti-Nazi education program for their children.

But the parents were turned down.

The bookstore, located at 7608 West Vernor, has been the source of controversy since it opened in mid-December.

Steven Handicus, a parent of youngsters at one of the Region 2 schools, told the board, "We have defended the right of the Nazis to speak, but we have a responsibility to our children as

well. Teachers are unsure of what they should say and how they should respond to the questions their pupils ask about this group.

"A number of groups, such as the Anti-Defamation League, have offered to come into any school at any time to speak, and they are not being utilized."

"Our children are very aware of the Nazis and what they stand for. But they are confused by our lack of action and the fact that their teachers and responsible adults are not doing anything about this group."

Other residents asked for security guards in the two elementary schools nearest the bookstore.

Region Supt. Joseph Miller told the parents that each individual school in the region has the option of choosing its own program for dealing with the problem. Miller added, "This group has been under constant surveillance. As it is now, they have broken no laws."

On the question of guards in the two elementary schools, he said, "We can not take security guards from our middle schools and high schools, where we are dealing with incidents of violence and drug abuse."

Board member Walker added, "If we were to pull our security officers out of our high schools, we might have a race riot. Is that what you want?"

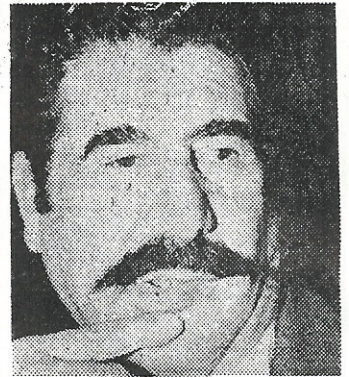

## ACE IN THE HOLE

I was born in Ireland and came to Chicago with my parents as a small child in 1921. We lived in a predominantly German neighborhood and had fine people as friends and neighbors. They, like us, were honest, decent, hardworking, hospitable WHITE people and we had grand times together. They went to our Irish parties and we went to their Beer-fests; we didn't have a lot of money but we sure had a good time. As a result, I learned the German language and this became my "ACE IN THE HOLE."

It was particularly handy during the Depression when shopping for bargains on MAXWELL STREET (a Jew ghetto market). There is a saying in Chicago that if anything was stolen, you could buy it back from the Russian Jews on Maxwell Street. This took a lot of haggling, a necessary factor in dealing with Jews and Gypsies. I could get a decent price by listening to them clacking in Yiddish (corrupted German). The Jews didn't know this dumb Mick could understand! What a bunch of dirty chislers they are! What a rotten business reputation they have!—just like Fagin (Begin).

My ACE IN THE HOLE also came in handy when I was stationed in Germany from 1945 to 1947. I felt ashamed of my US

uniform and the atrocities committed in the name of the US Government. I wished my parents had stayed in Ireland. The Jews of hate, many of them from Russia, were in American uniforms and running everything! It was these International Jews who forced the vicious Morgenthau Plan to ruin Germany's economy and starve the German people. They ran the infamous Nuernberg Trials like criminals passing judgment on the innocent. Then there were those UNRRA camps run by Int'l Jews for Int'l Jews with American dollars!

From the Jewish refugees, I overheard a lot. They were all coached to say they were in Nazi concentration camps and lost all their relatives in the gas chambers. The truth was these Jews were in Russia the whole time and never saw a death camp! Least of all a German one! This gave the Jew an excuse to further persecute the downtrodden and hungry Germans; to plunder what was left, to run the black market with American supplies and Jewish army personnel. I returned to Chicago in 1947 when it was becoming blacker and blacker. So I left for San Francisco, where I met a lovely Coleen at the

Hibernia Club, got married and lived in the pretty City by the Bay. Less than 20 years later the same thing happened to San Francisco and the old charm was gone. The neighborhood became a slum and the Whites were moving out. We took our teenage children back to Ireland in 1967 and have been doing just fine ever since in Erin.

I'm a lover of "Good Time Jazz." All this Holocaust stuff reminds me of the great song, immortalized by Bob Scobey's Frisco Band, and sung by the late Clancy Hayes, whom I knew quite well: "They'll tell you of horrors, they never have seen, From Skokie down to the Hollywood Bowl; For their names would be MUD, like a chump dealin' STUD, If they lost that old... ACE IN THE HOLE."

The 6 million LIE is the Jew's hole card. They well know if the American people got wise to their CON GAME, they'd ship them back to Russia in the same financial shape in which they came to America.....

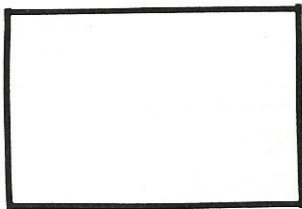

3. Decided Reds could TEACH VIOLENT OVERTHROW of U. S. Government, if they did not "investigate action".
4. Decided U. S. cannot dismiss loyalty suspects, if they are not in very "sensitive" positions.
5. Denied authority of Sec. of State to dismiss employees in the interest of the United States.
6. Reversed New York State's law automatically dismissing teachers who took fifth amendment.
7. Denied authority of States to question state teachers on suspected Communist activities.
8. Denied the plain-language authority in the Immigration Act to deport aliens who won't answer loyalty questions.
9. Decided that membership in Communist Party in 1930's does not raise any doubt of person's moral character.
10. Denied right of State Bar Examiners to exclude Reds.
11. Opened the FBI files to accused Communists.
12. Restraind powers of House Committee to investigate Un-American and Subversive Activities.
13. Denied authority to states to investigate Communists.
14. Reversed all Ohio courts on conviction of man who refused to answer questions on Red activities.
15. Set aside convictions of Fluors for delaying subpoena of Senate Internal Security Subcommittee.
