

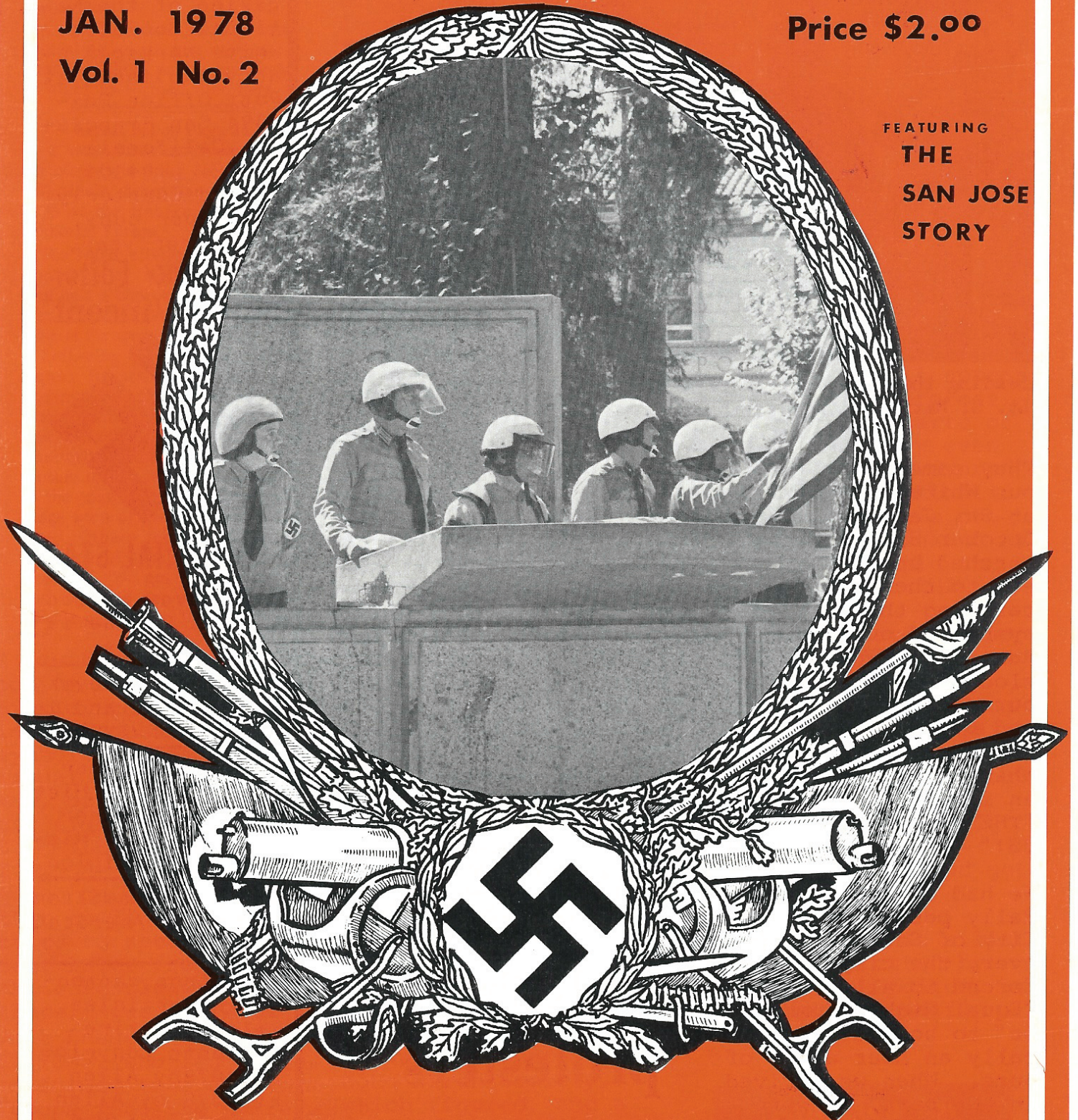

THE HEARTBEAT OF WHITE REVOLUTION

ALL THE WAY TO SAN JOSE

They came to disrupt our White Power Rally at St. James Park on October 8, 1977. We marched up Second Street to the Park proudly carrying the ancient symbol of our Aryan Race, THE SWASTIKA, alongside the pride of our country, the Stars and Stripes. We came together to give our White Race in San Jose an inspiring message: "THE FUTURE BELONGS TO US!"

We had obtained the Rally permit from the City of San Jose. However, the city were forced to allow the "Equal Rights Committee" to hold a counter rally an hour ahead of ours. When we arrived in the park, we were nearly overwhelmed by the screaming liberal elements of the over

2,000 present. We literally shoved, punched, kicked, and shouldered our way through the hysterical masses of Reds and Marxist Jews. We finally marched our way to the speaker's platform and hoped the clamoring and howling by the Jew-Communist would die down so we could be heard. The following excerpts from the Sunday San Jose Mercury News, Oct. 9, should indicate what we had to contend with.

S.J. cops seize 18 during rally

Eighteen people were arrested Saturday afternoon for throwing garbage and forcibly trying to break up a Nazi "rally" in St. James Park.

A crowd of about 2,000 — some protesting, some just curious — lined up behind police barricades as eight uniformed members of

the ultra-right wing faction stood with their American and Nazi flags at the Robert F. Kennedy Memorial Forum.

The Nazis attempted to deliver a message of "white power." Vincent held a book whose cover bore that title throughout the rally. But little of his speech was heard.

Left-wing organizations — the Equal Rights Committee, the Communist Labor party, the National United Workers Organization, and others — joined in a pre-Nazi rally of their own in another section of the park. Some groups at the counter-rally sang protest songs born of the anti-war movement. Others took to bullhorns with talk of "No free speech for fascists," "We got 'em in the 40s and we gotta get 'em now," and "We've got to stop the fascist rally."

I saw from the speaker's podium the red Hammer & Sickle, the Star of David, and other anti-WHITE symbols of the International MARXIST-ZIONIST. And, of all things, a big sign saying, "DID SIX MILLION DIE IN VAIN!" I didn't know what was going on down there in that howling mob as I tried to speak but I did hear later from many White People who were there. Our San Jose Unit Leader, LARRY STEVENS, who led a non-uniformed team of Storm Troops into the hysterical Jew-led elements, had this to report:

More than one person reported they overheard these so-called Jewish Survivors egging on Chicano Power groups to "kill those Nazis;" to get a few Fascist Pigs at the same time (referring to the White police officers who, I must stress, did an outstanding job that day in containing many of the suckers led on by the Jews).

The Communists shouted "Gas Chambers for Nazis," "No Free Speech for Nazis." The Equal Rights Committee screamed "Murder those Nazis." But it was the AUSCHWITZ SURVIVORS who really turned the trick!

They were howling for our blood and shrieking like maniacs. Some tried to break police lines when they heard me say that we should get rid of the GANGSTER STATE OF ISRAEL! They got nowhere. Two squads of black uniformed San Jose police beat these creeps to the ground in a White display that others had the RIGHT TO FREE SPEECH!

A White Lady who wanted to hear me was rudely shoved by "STILL-ANOTHER" Jew "survivor" from Cracow. This Jew was abused when she told him to pipe down! The Jew accused this White Lady of being a NAZI, but she thereupon accused this jerk of being a Communist. The Jew denied this saying that he was a member of the John Birch Society, which figured, and a good AMERICAN citizen, which definitely does not figure!

She and her husband have now joined the N S W W P and are actively working in San Jose.

Many other White People became interested in us too, even though this "ORGANIZED HATE" campaign prevented me from finishing my speech. We found out much more!

It seems the Jewish Defense League and the Marxist Jew-led Progressive Labor Party had been at work in San Jose all that October 8 week. They rounded up the minorities and herded them in like sheep from all over the State to make it appear as a San Jose protest. Besides other parts of California, they even brought in "Survivors" from Skokie, Illinois, for this gigantic protest little thinking it gave White People the chance to hear THE HOWLING JEW!

A White bartender reported that foreign Jews paid some White dere-licts the "Thirty Pieces" to throw garbage at us and scream for our White blood. After our Rally broke up, this scum flooded into his bar with their Jew-stained shekels and got stoned.

Of the 18 people arrested in connection with the Nazi rally in St. James Park Saturday, 14 reside outside of Santa Clara County, information released by police showed.

San Jose residents arrested were Carol Goytia, of 370 Vaughn St., on charges of attempting to incite a riot; Gideon D. Amir, of

2562 Mill Park Drive, for assault and battery, and Frank Morera, of 400 S. 13th St., for various outstanding warrants. Another county resident arrested was Linda Crouse, of 2236 Oakwood Drive, Palo Alto, on a charge of attempting to incite a riot.

Others arrested were Walter Davila, Robert Bitner, Marlene Duenas and Kathy Glasser, all of San Francisco, on charges of malicious mischief and inciting a riot.

San Francisco residents also arrested were Sheldon Jones, on four misdemeanor charges including assault; Michael Glasser, for inciting a riot and assault and battery; James Fauss, possession of an illegal weapon; Larry Orloff, assault with a deadly weapon on a policeman, resisting arrest and inciting a riot, and Catherine Weiser, resisting arrest, disturbing a public meeting, inciting a riot and for having no loud speaker permit.

The others arrested, according to police, were Maria Garcia, of Los Angeles, on charges of attempting to incite a riot and assault; Roland E. Angle, of Alameda, for disturbing the peace and assault and battery; Zennie Harris, of Englewood, for inciting a riot and assault and battery; William P. Ryle, of El Cerrito, of disturbing the peace and inciting a riot, and George Hernandez, of Los Angeles, of malicious mischief and inciting a riot.

The "enemy" thought they had defeated us when we left after more than an hour on the St. James Park podium. But these Marxist Jews actually put us across to the White People. These lousy creeps only added emphasis to our MESSAGE!

We really owe these Jew-Communist a debt of thanks for opening the eyes of WHITE PEOPLE in Santa Clara County to the dangers they face. We thank all those "Auschwitz Survivors" for this! These International Marxist Jews and the sheep they lead really put us over!

Court Rejects Appeal On Nazi Phone Tapes

Washington

The American Nazi party in Houston was refused permission yesterday by Supreme Court Justice Lewis Powell to resume playing tape-recorded telephone messages offering \$5000 prizes for non-white killings.

Powell denied without comment a request from the Nazis that he set aside a state court order temporarily barring the playing of three such tapes over the telephone.

Still pending is a similar request to the Texas Supreme Court, *Associated Press*

THE MYTH OF SIX MILLION

For our readers interested in FACTS instead of Fiction, we present the following article by a noted historian, author, and legal authority.

One of the most widely believed and yet totally false stories is that of the HOLOCAUST. According to the promoters of this legend, the German National Socialist Government deliberately exterminated European Jewry to the full extent it was able before the so-called "Liberation" by the "Allied" Nations.

This action was supposedly started in July 1941 with Hitler's orders for the liquidation of the Communist indoctrination commissars in the Red Army. The written order for the extermination of the Communist Commissars (which is genuine) was purportedly accompanied by verbal orders to liquidate Russian Jewry. This was Phase One, with Phase Two being the deportation of all European Jews to Poland for extermination.

While historians do accept the "Final Solution" goals meant emigration of European Jewry to America, Palestine,

South America and other global spots from the Continent of Europe, this became an impossibility with the onset of World War II and the collapse of the "Madagascar Plan" due to the serious situation on the Russian Front.

The French Colonial Office maintained a rather nebulous attitude on the Madagascar Project in its negotiations with the Germans after the Fall of France in 1940. As late as March 1942, Goebbels, the Nazi propaganda chief, wrote a memorandum in favor of resettling the European Jews on the Island of Madagascar. But Goebbels went on to state that due to the war it was temporarily impractical and the Jews would be resettled in the "Government General" area of Poland in their own ethnic enclaves.

There are two reasons for that forced resettlement of Jews in Poland: (1) To minimize partisan guerrilla activities in obvious hostile elements. (2) As a vital source of manpower for the huge chemical-industrial complex at AUSCHWITZ-BIRKENAU and other labor camps. This was to fulfill the crucial manpower shortage in Ger-

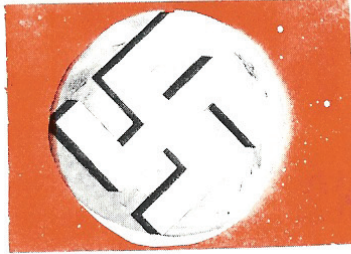
many's wartime capacity during the world conflict.

The first to make charges of "mass extermination" was a Polish-Jew refugee, Prof. Rafael Lemkin, in his 1943 wartime book, "Axis Rule in Occupied Europe." Lemkin made the now familiar "gas chamber" claims. He claimed at that date (mid 1943) that the Nazis had ALREADY exterminated possibly as many as "Six Million Jews." This in 1943, would indeed be remarkable since the "jewocide" allegedly began only in the summer of 1942! At that rate the entire world Jewish population would have been reduced to ashes by 1945. Even more fantastic nonsense was spread by the world Jew propaganda media after the War.

Kurt Gerstein, an anti-Nazi who claimed to have infiltrated the SS, told the French interrogator at Nuernberg, Raymond Cartier, that he knew no less than "forty million" concentration camp inmates had been gassed. Gerstein later reduced the figure to "twenty-Five Million" and then again lowered it to the final SIX MILLION figure desired

GREAT BRITAIN & IRELAND

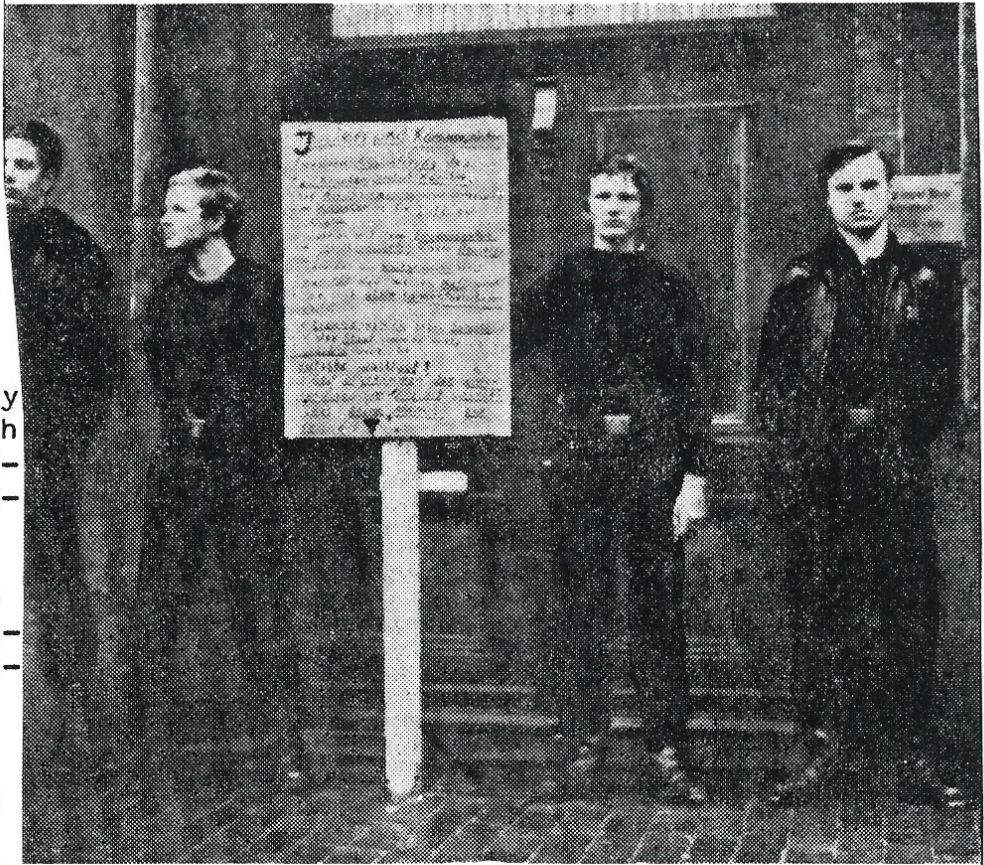
"THE PRUSSIAN GUARD"

LONDON — Huge racist slogans suddenly appeared last week on a fence in a quiet south London suburb. Red swastikas border the words "National Front," the leading British fascist party.

The signs face large public housing projects, part of the ruling labor party's program to disperse the lower classes. One of the buildings contains mostly whites and a neighboring one mostly blacks.

The suburb is far removed from the scene of a recent violent demonstration over the National Front, and the signs are a jarring sight to local residents. The same signs have been appearing in other

quiet neighborhoods where such slogans have never been seen before.

Britain has weathered many small extremist groups, which disappeared as quickly as they appeared. But more people seem to be worried this time, a sentiment that coincides with mounting unemployment, a sharp drop in living standards and huge inflation rates.

Two weeks ago, in the south London district of Lewisham, 500 members of the Front, protected by 4,000 police, marched past impoverished residences housing many blacks. Members of the left extremist party, the Socialist Workers, attacked with stones, bottles, bricks, knives and ammonia. More than 200 police were injured and 200 people, mostly socialist workers,

were arrested.

Last week, a similar incident occurred in Birmingham and 50 more police officers attempting to protect the National Front march were injured.

A few days later, in a by-election in a Birmingham district, the Labor candidate was elected to Parliament by a much smaller margin than his predecessor. The National Front candidate came in third behind the Conservative candidate. The candidate representing the liberal party, the nation's third largest, placed fourth.

But left-wing leaders make clear they intend to continue to disregard the favorable light their attackers cast on their fascist opponents. The SWP leaders say they

remember what happened in Germany and Spain 50 years ago, and will not remain passive when fascists march through working districts.

The National Front, with a membership of only a few thousand — fewer than the SWP — has received a great deal of publicity in the last two weeks by claiming its right to parade peacefully for an apolitical cause must be inalienable. The cause appeals to the white working class, which feels threatened by "aliens" for both housing and jobs.

The parade through the London district included posters claiming that the majority of London muggers are black and most victims are white. The British fascists'

primary target is blacks, most of whom originally came here from the West Indies, and browns, Indians and Pakistanis, many of whom fled here from East African persecution.

The leader of the National Front, John Tyndall, served in the army as a corporal, then was a salesman. He was tried in 1962 on charges of running a military organization. At that time he testified: "I have no morbid fascination for daggers and jackboots but I read 'Mein Kampf' and realized every word of it was true."

It may well be that developments in the last two weeks have exceeded Tyndall's fondest dreams, Swastikas, and racist scrawls and the words "National Front" appear on many walls in subways and railroad stations.

Critics have charged that police lacked common sense in insisting on letting the National Front marches proceed. British police use shields and clubs but still don't wear side arms in such situations here. A police spokesman said he hoped it would not be necessary for British police to maintain a special force to deal with demonstration, as in France or most major American cities.

The fact that our system of Justice is so biased we could receive no compensation for the loss and the criminals who destroyed our property were not prosecuted, were additional factors in our favor:

STEVEN HANSEN: Holds a JD and is a Dr. of Laws. He has devoted many years of research and travel to ferret out the truth behind that Kangaroo Court at Nuernberg, which was a disgrace to American justice and violated every legal code in the book. As any good lawyer, he has documented much evidence and analyzed all testimony given at the Trials. This is the first of a 3-part series. The 2nd and 3rd installments will be carried in our Spring and Summer issues of STORMER.

PETER W. FISCHER: Is a Prof. of History and Religion, familiar with Latin, Greek and German. He was born in the USA of German parents. As a youth went to Germany in the 1930s to live with relatives, so he knows

how life really was in the Third Reich. He and his parents were interned in 1942 as "security risks" because they had joined the Bund and the America First movement to keep the USA out of WW II. He will write an article for our SPRING issue on the "CRUCIFIXION," recorded by the Romans as a political trial from Roman history and "The Acts of Pontius Pilate." He compares this to the NUERNBERG trials and this really is an eye-opener.

VLADIMIR PETROVSKY: Holds a PhD and other degrees and is a real SURVIVOR! Born in 1910 in St. Petersburg, Russia, he saw his father, a priest, murdered by the Reds in 1920, his mother and sister ravaged and other horrible things. He was taken away and never saw his family again.

After years of forced Marxist brainwashing by tyrannical Jewish instructors, he managed to escape first to Estonia and then to East Prussia.

In 1933 he joined the NSDAP. As a White Russian, he did much work for the party in weeding out Communists; became an officer and fought bravely with the Cossack unit in WW II. When the "Allies" turned these Cossacks over to the Reds for extermination, he again escaped and fled to Arabic countries where he was safe following WW II.

He now speaks Arabic in addition to four other

languages. Dr. Petrovsky will have a real HOLOCAUST story for us in our next issue (not a hoax or myth, but the truth!)

GORDON L. HAMILTON: A retired American officer, can trace his American heritage to the year 1714. He is a member of "Sons of the American Revolution," and his ancestors distinguished themselves both on the battlefield and in early American politics.

Disgusted with our sellout to the Reds at Yalta & Potsdam, he has tried to figure out why FDR betrayed us and why we were lied to. He has studied American history and one of his favorite subjects is BENJAMIN FRANKLIN.

A few years ago he read "Mein Kampf" and was amazed Adolf Hitler and Franklin shared the same opinion on the Jews! As a military man, Mr. Hamilton feels we must mobilize and fight as we did 200 years ago. He and Dr. Petrovsky work together now and are a great combination.

The contributors from CAPITOL HILL wish to remain anonymous for obvious reasons. They are patriotic Americans who are part of the Washington scene and very much "in the know." One of them has been in Congress himself and knows how the "system" works.

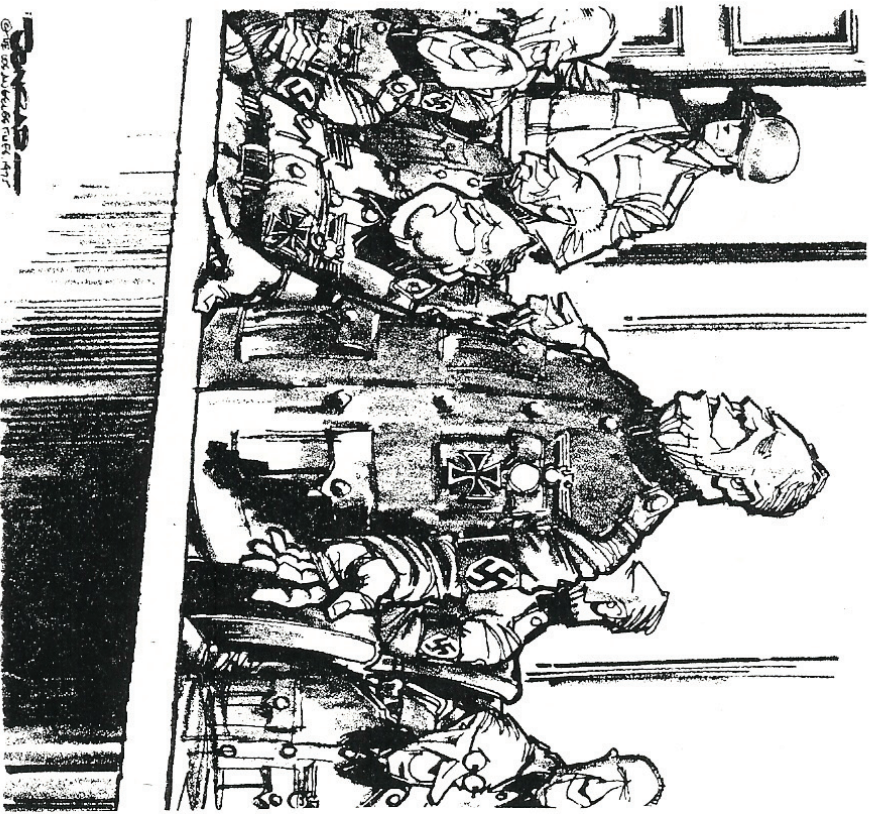

They gave him an undeserved sense of importance; they almost gave him a "martyr" or two—which he would have loved; and they gave his ragtag band of misfits a million dollars' worth of free publicity.

They probably didn't realize it, but they tried to give the First Amendment a drubbing into the bargain. All in all, it was a bad scene that doesn't deserve repeating.

One of the reasons democracy is the best, if not the tidiest, form of government is because it protects the freedoms of all citizens, even those who do not believe in freedom for all. 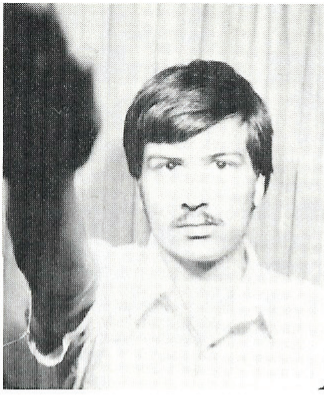

of the Anchor:

I am really amazed at the appearance of that letter signed by eight of my colleagues chastising the Anchor for printing what seemed quite clearly to be anti-Nazi, anti-racist articles in the paper. One is not so surprised when some of the less-informed and less perceptive members of the student body miss the point; but one ought to expect a higher level of understanding from the faculty and professional staff.

Both articles, "Just a Stone's Throw Away" (October 12) and "Hitler Visits R.I.C." (November 1), were attacks on the grotesqueness of race-thinking and Nazism. The first article gave a chilling representation of the monstrousness of Nazi stereotyping and the dehumanization of the Nazi murder machine. Are the chaplains offended by the suggestion of the complicity of "Christians" in the genocide of Jews? Maybe the chaplains have forgotten that most Christians in Germany acquiesced to the Nazi order, that the Conforming Church

of the Third Reich encompassed most Protestants and Catholics. There were not enough Bonhoffers and Niemüllers to save the nation. I hope that no one has forgotten that the Christian neighbors (Catholic, Protestant and Orthodox) of Jews quite happily turned the Jews over to the Nazis in Germany and in the conquered countries. One of the horrors of the Nazi regime was the fact that many of the practitioners could go to church every Sunday and then go back to work exterminating the Jews, gypsies, etc., the rest of the week. So let's have no more pious finger-pointing.

I fear that these correspondents want the treatment of such issues to be reduced to clear bumper-sticker language. Perhaps for penance, Kurt Sorensen and John-Paul Sousa ought to be made to write two columns each with nothing more than Nazism Equal

Genocide and Down With Racism. That would please just about everybody but Charles Labbe.

Area Nazis working to boost strength

Groups of Nazis distributing literature, staging demonstrations and opening businesses have become a familiar sight in the South Bay recently.

And one group, a chapter of the National White Socialist Workers Party, is

the first time in 20 years.

The group was composed of a surprising cross section: A former journalist, an accountant, a house painter, a couple of manual laborers, numerous housewives with children in tow and a computer programmer.

Germans, an Australian and a Czechoslovakian were included in the group of about 30 Nazis.

Seated in the modestly appointed, middle class home, the Nazis watched home movies of confrontations with the Jewish Defense League (JDL). Their

remarks left little doubt they had watched the bloody show many times.

The air was charged with racial hatred as they hurled slurs as their foes appeared; some prodded their children — who were playing with pop guns under the screen — to aim at JDL

members in the movies.

Race was the predominant factor when Steward and Vincent expounded their organization's dogma.

"Marxist socialism is the opposite of what our party stands for," they said.

"Nazis believe in private property and free enterprise within a social framework like Hitler's Germany.

"We believe the Constitution in this country provides for equal rights but no equality.

"That is where we differ with the Communists in the government and the media today.

"Races are not equal."

Vincent said their ideal society is one with 'white people ruling and the Jews and blacks in lower gradients left to tend for themselves."

Asked what he proposed to do with the large population of so-called inferiors Vincent said, "I would send the Jews to the Belgian Congo and let the blacks solve the problem."

He said the party doesn't advocate violence as a means to an end. It hopes to gain power through the ballot box.

"Violence would only be resorted to in the case of a total breakdown in society," Steward said.

"We believe in an international conspiracy theory like what Hitler believed in — where communists in different governments around the world are plotting to ruin the world and white race by advocating mixing of the races," Steward said.

Schloegl said he has no problem carrying on a normal life as a Nazi, adding his fellow employees at a large national insurance company are aware of his political leanings and accept him.

THE MYTH OF THE SIX MILLION

by the French prosecutor, Dubost, at the "judicial farce" known as the NUERNBERG TRIALS.

Gerstein claimed to have witnessed the most fantastic "mass executions" at camps where it is even now acknowledged by official Jewish sources, such as the Jewish Agency in Tel Aviv, that no such "gas chamber exterminations" took place. The Nuernberg Tribunal even refused to admit this forged effrontery into evidence. It was the World Press that was responsible for publicizing this FRAUD and lending it an air of "authenticity."

Gerstein even described in detail an alleged visit by Hitler to a concentration camp in Poland on June 6, 1942, which is known to have never taken place!

Another so-called witness was a Dr. Wilhelm Hoettl, who had written several books under the pseudonym of Walter Hagen. Hoettl was a former assistant to Adolf Eichmann and, in fact, was an agent of the OSS American Intelligence. Hoettle apparently also worked for Soviet Intelligence (then our "noble ally"), and had collaborated with two Jewish emigrants from Vienna - Verber and Perger - who amazingly enough acted as UNITED STATES OFFICERS during the pre-trial inquiries of the Nuernberg Tribunal.

The dubious testimony of Hoettl is said to constitute the only "proof" regarding the

alleged murder of SIX MILLION Jews. In his affidavit of November 26, 1945, he stated he did not know of the murders firsthand, but that Eichmann allegedly "told him" in August 1944 in

Budapest! Since Hoettl was working as an American spy during the latter period of the War, it is very strange indeed that he never informed his American superiors of such a monstrous plot.

It needs to be particularly emphasized that there is not a single document in existence which proves the Germans ever intended to, or carried out, any deliberate murder of Jews.

In the flood of "Atrocity Books" by such "authorities" as Reitlinger, Poliakov, Arendt, Hilberg, et al, which have appeared since the War, the most these "experts" can assert are statements extracted after the war under physical and psychological TORTURE from people such as Gerstein, Hoettl, Ohlendorf and Wisliceny.

Therefore, in the absence of any concrete, factually provable evidence, Poliakov writes: "The three or four people chiefly involved in drawing up the plan for total extermination are dead, and no documents survive."

We will announce the date on our taped phone messages ahead of time so you can see the show!

If they, KTVU, hadn't done this, I would have taken my case to the Supreme Court....like Allan Bakke did!

I also advised KTVU that I am not the organizer of this ANTI-WHITE HATE. I am not an organizer for the Communist Party; nor do I run the TV networks in New York, the Porno mills in Hollywood, the minority gangs out to "Get Whitey or Kill the Pigs," etc.; I do not lead the A.C.L.U.,

nor do I write dirty comic books and "Hate The Honky Poison."

I advised KTVU that we are organized to protect the WHITE RACE and NATION to combat this Hate. We, in fact, could be called an "ARYAN ANTI-DEFAMATION LEAGUE"!

If the old saying is true that misery loves company, then ALLEN VINCENT has plenty of it.
