## Holocaust Revisionism

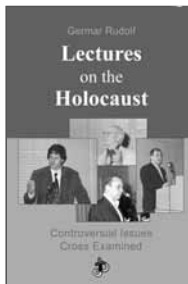
### #29: **Germar Rudolf: *Lectures on the Holocaust. Controversial Issues Cross Examined***

In 1976, Holocaust revisionism produced its last "standard work:" A.R. Butz' *Hoax of the Twentieth Century*. "How can a quarter century old text not be obsolete today?" Butz asks in the preface of the 2003 edition of his own book, pointing out "the age of this text, and the great advances that have subsequently occurred in Holocaust revisionism." Hence, there is a great need for a new, integrated work summarizing Holocaust revisionism.

**And here it is, the new standard work of Holocaust revisionism!** It was written by German scholar, writer, and publisher Germar Rudolf, based on the research of the most prominent revisionists, most of which Rudolf had the pleasure of publishing in a multitude of German and English language journals and books over the past 15 years. *Lectures on the Holocaust* fits the need of those who have no in-depth knowledge of the Holocaust or of revisionism, as well as of readers familiar with revisionism. Anyone who wants to bring himself up to date on revisionist scholarship needs this book!

The book's style makes it unique: It is a dialogue between the author, who explains the most important arguments of, and objections to, revisionism, and the reactions of a virtual audience, which includes supportive, skeptical, and hostile comments, questions, and assertions. *Lectures on the Holocaust* reads like a vivid real-life exchange between persons of various points of view, like a compendium of Frequently Asked Questions on the Holocaust and its critical re-examination. There is no better book for introducing readers unfamiliar with revisionism to this highly controversial topic.

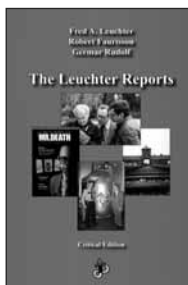


### #186: **F.A. Leuchter, R. Faurisson, G. Rudolf: *The Leuchter Reports. Critical Edition***

Some 44 years after WWII, in 1988, American expert for execution technologies Fred A. Leuchter changed the course of history, when he was asked to go to Poland and investigate the alleged homicidal gas chambers at the Auschwitz, Birkenau, and Majdanek camps. Leuchter concluded in his report: "There were no execution gas chambers at any of these locations." Later, Leuchter went to other camps, where mass murder with poison gas is claimed to have occurred (Dachau, Mauthausen, Hartheim). He wrote a similarly devastating report, which concluded "that there were no gas execution chambers at any of these locations." This study was accompanied by an annotated bibliography by Dr. Robert Faurisson concerning the claims regarding these three camps. In a third expert report, Fred Leuchter described the execution gas chambers used in the U.S. and compared them with claims about alleged Third Reich gassings.

This edition publishes all these reports in one volume and subjects the first of them, which has caused a huge controversy and triggered new research, to a thorough critique, backing up Leuchter's claims with more information and references, where he is right, and correcting him, where he erred.

#185: **Germar Rudolf, Carlo Mattogno:** *Auschwitz-Lies. Legends, Lies, and Prejudices on the Holocaust*

“French biochemist G. Wellers exposed the Leuchter Report as fallacious” – he exposed only his own grotesque incompetence. “Polish researcher Prof. J. Markiewicz proved with analysis that Zyklon B was used in the gas chambers of Auschwitz” – Markiewicz fabricated his results. “Chemist Dr. Richard Green showed that the revisionists’ chemical arguments are flawed” – Green actually had to admit that the revisionists are right. “Prof. Zimmerman proved that the crematories in Auschwitz could cremate all victims of the claimed mass murder.” – as an accountant, Zimmerman proved only his lack of knowledge. “Profs. #187: **Germar Rudolf (ed.):** *Auschwitz: Plain Facts. A Response to Jean-Claude Pressac*

With two major works on the Auschwitz concentration camp, French pharmacist Jean-Claude Pressac tried to refute revisionists with their own technical methods. Whereas his first work remained rather obscure, Pressac’s second book on “The Technique of Mass Murder” was praised by the mainstream in Europe, who then proclaimed victory over revisionism. But they did not reckon with the revisionists...

In *Auschwitz: Plain Facts*, Pressac’s works are subjected to a detailed and devastating critique by leading revisionist scholars. Although Pressac deserves credit for having made accessible many hitherto unknown documents, his writings could not refute the revisionists. Neither did Pressac adhere to scientific nor to formal standards when interpreting documents: He made claims that he either could not prove or which contradict the facts. Many documents he quoted do not state what he claimed they do. But most importantly: He did not pay any attention to “the technique” of the mass murder at issue, as his books claim. Neither do his books contain references to technical or scientific literature, nor are there any technical considerations in them. In fact, he reveals such a massive technical incompetence that his works more properly belong in the category of novels rather than history. Despite these deficiencies, Pressac is still hailed as the savior of the Auschwitz-Holocaust by the mainstream.

*Auschwitz: Plain Facts* is a must read for all those who are in search of the realities as opposed to the falsehoods and half truths of established historiography.

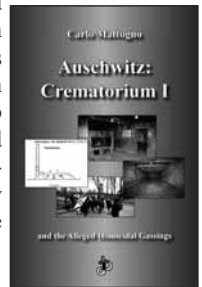

#192: **Carlo Mattogno:** *Auschwitz: Crematorium I and the Alleged Homicidal Gassings*

The morgue of crematorium I in the Auschwitz concentration camp is said to have been the first location where mass gassings of Jews occurred over an extended period of time. In this study, Italian scholar Carlo Mattogno analyzes the most important witness testimonies and juxtaposes them with original German wartime documents as well as material evidence still available today. Mattogno shows that the witness testimonies are contradictory, physically impossible, and refuted by documents and by forensic evidence. Mattogno also exposes mainstream historians for their attempt to convert black propaganda into “truth” by means of omissions and distortions. This crematory’s morgue is shown to have been only what it was meant to be: a morgue.

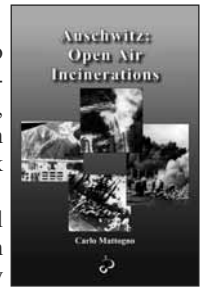
**#191: Carlo Mattogno: *Auschwitz: Open Air Incinerations***

In spring and summer of 1944, 400,000 Hungarian Jews were deported to Auschwitz and allegedly murdered there in gas chambers. The Auschwitz crematoria are said to have been unable to cope with so many corpses. Therefore, every single day thousands of corpses are claimed to have been incinerated on huge pyres lit in deep trenches. The sky over Auschwitz was covered in thick smoke. This is what some witnesses want us to believe.

This study investigates all available documentary, physical, and anecdotal evidence. Carlo Mattogno shows that the witness statements contradict each other in every regard. They also contradict what would have been physically possible. The fact that there is no documentary or forensic evidence supporting the claims is finally explained by air photos taken by German and Allied air planes in 1944. They prove that the witnesses were wrong: No traces of huge pyres or massive smoke covering the camp can be seen.

Although based on a kernel of truth, Mattogno concludes that the witness statements are vastly exaggerated, and their homicidal claims are untrue.

**#160: Francis Nicosia: *The Third Reich & the Palestine Question***

In order to ensure its racial, ideological, and strategic interests, the Hitler regime actively supported the status quo in Palestine and the Middle East during the interwar period. This included the perpetuation of British imperial power in Palestine, the Jewish National Home (not an independent Jewish state) promised by the Balfour Declaration, and the rejection of Arab self-determination and independence.

*The Third Reich and the Palestine Question* is the first comprehensive study of German Palestine policy during the 1930s. Francis R. Nicosia places that policy within the context of historical German interests and aims in Palestine, the Middle East, and Europe from the Wilhelminian era through the Weimar period and the Third Reich. He also provides insight into the broader foreign policy aims and calculations of the NS regime throughout the Arab Middle East before World War II.

In a new introduction, Nicosia places his ground-breaking research in its proper historical perspective. He also discusses some of the archival materials that have recently become available in the former German Democratic Republic and Soviet Union.

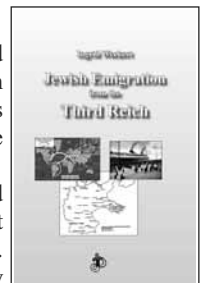


**#182: Ingrid Weckert: *Jewish Emigration from the Third Reich***

Current historical writings dealing with the treatment of Jews by the Third Reich paint a bleak picture. To this day there are still accounts of the Jewish emigration that depict it as some kind of clandestine operation – as if the Jews who wished to leave Germany had to sneak over the borders in defiance of the German authorities, leaving all their possessions and wealth behind.

The truth is that the emigration was welcomed by the German authorities, and frequently occurred under a constantly increasing pressure. Emigration was not some kind of wild flight, but rather a lawfully determined and regulated matter. Weckert's booklet elucidates the emigration process in law and policy, thereby augmenting the traditionally received picture of Jewish emigration from Germany. German and Jewish authorities worked closely together on this emigration. Jews interested in emigrating received detailed advice and offers of help from both sides. The accounts of Jews fleeing Germany in secret by night across some border are untenable.

## #190: Roger Garaudy: *The Founding Myths of Modern Israel*

In this headline-making work, a prominent French scholar delivers one powerful blow after another to the pernicious historical myths cited for decades to justify Zionist aggression and repression, including the Israeli legend of a “land without people for a people without land,” and the most sacred of Jewish-Zionist icons, the Holocaust extermination story. For financial gain, as an alibi for indefensible policies, and for other reasons, Jews have used what the author calls “theological myths” to arrogate for themselves a “right of theological divine chosenness.” The wartime suffering of Europe’s Jews, he contends, has been elevated to the status of a secular religion, and is now treated with sacrosanct historical uniqueness.

This readable, thoroughly documented study examines the brutal dispossession and mass expulsion of Palestine’s Arabs, exposes the farce of the Nuremberg victors’ show trial, and shows that the notorious German “final solution” term referred to a “territorial” program of resettlement, not extermination. *Founding Myths* details the secret collaboration of prominent Jews with the young Nazi regime, and the 1941 offer by some Zionists, including a future Israeli prime minister, to join Hitler’s Germany in a military alliance against Britain. The author presents a frank assessment of the powerful Jewish-Zionist lobby in the United States, showing how it effectively controls US policy regarding Israel, and plays a crucial role in shaping American public opinion.

For decades Roger Garaudy was prominent in the French Communist Party, making a name for himself as a Communist deputy in the French National Assembly, and as a leading Marxist intellectual and theoretician. Later he broke with Communism, eventually becoming a Muslim. When *Founding Myths* first appeared in France, it touched off a storm of controversy among intellectuals and a furious uproar in the media. Soon Garaudy was charged with violating France’s notorious Gaysot law, which makes it a crime to “contest” the “crimes against humanity” as defined by the Nuremberg Tribunal of 1945-46. A Paris court found him guilty and fined him \$40,000. His trial and conviction for Holocaust heresy prompted wide international support, above all from across the Arab and Muslim world.

Relying on a vast range of Zionist, Soviet, American, and German source references, this well-documented study is packed with hundreds of eye-opening quotations, many by prominent Jewish scholars and personalities. Here, at last, this important work is available in a handsome, professionally edited English-language edition, with a valuable foreword by Theodore J. O’Keefe.

## #198: John Sack: *An Eye for an Eye. The Story of Jews Who Sought Revenge for the Holocaust*

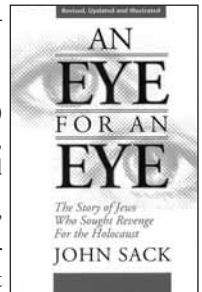
Not for sixty years has a book been so brutally (and, in the end, unsuccessfully) suppressed as *An Eye for an Eye*. One major newspaper, one major magazine, and three major publishers paid \$40,000 for it but were scared off. One printed 6,000 books and then pulped them.

Two dozen publishers read *An Eye for an Eye* and praised it. “Shocking,” “Startling,” “Astonishing,” “Mesmerizing,” “Extraordinary,” they wrote to author John Sack. “I was riveted,” “I was bowled over,” “I love it,” they wrote, but all two dozen rejected it. Finally, BasicBooks published *An Eye for an Eye*. It “sparked a furious controversy,” said Newsweek. It became a best-seller in Europe but was so shunned in America that it also became, in the words of *New York*, “The Book They Dare Not Review.”

Since then, both *60 Minutes* and *The New York Times* have corroborated what Sack wrote: that at the end of World War II, thousands of Jews sought revenge for the Holocaust. They set up 1,255 concentration camps for German civilians – German men, women, children and babies. There they beat, whipped, tortured and murdered the Germans.

“The events are vivid, the language is powerful, the conclusions appear just. The book should be read and become part of the all too gruesome document the world calls history,” *New York Daily News*.

## The World Wars

### #161: James Bacque: *Crimes & Mercies. The Fate of German Civilians Under Allied Occupation, 1944-1950*

This book focuses largely on the grim, post-war fate of 60 million German civilians. But it is probably on page 131 that we find the epicenter of the book, and its seismic thesis; it is here, in a little, statistical chart, that Bacque's findings may be seen in a single glance.

"Expellees" refers to the 16,000,000 ethnic Germans who were brutally driven from their ancestral homelands in East Germany, Poland, Hungary, Czechia, Yugoslavia, and elsewhere in Europe, at war's end. "Prisoners" are German POWs as well as person in "automatic arrest" or those deported for slave labor, the subject of Bacque's first book *Other Losses*. "Residents" here refers to the German civilian population that survived the Second World War.

"These deaths have never been honestly reported by either the Allies or the German government," Bacque says, and he exposes the Allies' motives: the unabashed inhumanity of the Allied leadership, the worst being U.S. Treasury Secretary, Henry Morgenthau, Jr., who hatched the serpent's egg: the vicious, vengeful Morgenthau Plan for the post-war reduction of the German population down to some 20 million. Devised, "cancelled," then implemented via the punitive directive JCS/1067, the Morgenthau Plan wreaked havoc on Germany and Europe in general.

By starkest contrast, the hero of the book – and to whom it is dedicated – is Herbert Hoover. It was Hoover who lobbied for a food program for the relief of Germany, which put an end to the Morgenthau nightmare and rescued literally millions of people from a slow, agonizing death. Bacque also shines a hard light on the Western media for concealing or outrightly denying the Allies' complicity in numerous atrocities.

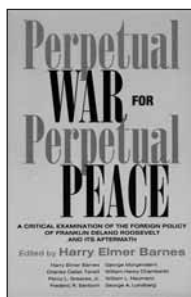
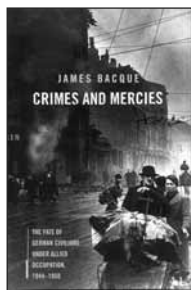
### #175: Harry Elmer Barnes: *Perpetual War for Perpetual Peace. A critical examination of the foreign policy of Franklin Delano Roosevelt and its aftermath*

This book is one of those rare historical classics that serve as guides not merely to the past, but to the future. Forty years after it was first published (in 1953), it remains the most authoritative, and the most comprehensive, revisionist account of the real causes and the actual results of America's entry into the Second World War. The work of eight outstanding American historians and researchers, under the editorial leadership of the brilliant historical polymath and controversialist Harry Elmer Barnes, this book is more than the "critical examination of the foreign policy of Franklin Delano Roosevelt" promised in its subtitle: it is a scholarly expose, measured and relentless, of the calculated deceit by which FDR overturned America's traditional neutrality policy, provoked Pearl Harbor (while forcing his soldiers and sailors to shoulder the blame), and waged a brutal, pointless war, which culminated in mass slaughter at Dresden and Hiroshima and betrayal of America and the West at Yalta and Potsdam.

This work establishes convincingly that America's participation in the Second World War was neither necessary, nor desirable. But even in 1953, Barnes predicted that America would continue to be embroiled in military adventures and alarms around the globe as a result of U.S. imperialism.

Today, almost half a century after VE-Day and VJ-Day, the long road back to the foreign policy by which America flourished strong and free begins by establishing the facts and righting the record on our intervention into the Second World War. For that, there is no better tool than this book.

## #196: **Werner Baumbach: *The Life and Death of the Luftwaffe***

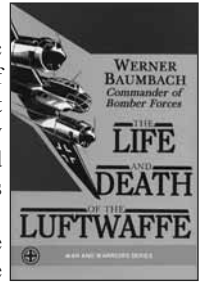
*The Life and Death of the Luftwaffe* is the remarkable story of the meteoric rise and precipitous fall of one of history's great air forces, as told by one of its most decorated and honored officers, Colonel Werner Baumbach. A combat pilot who braved enemy fighters and AA fire to dive-bomb targets in virtually every German theater of WWII, Baumbach was also a superb organizer and keen strategist who was named the Luftwaffe's Commander of the Bombers well before his thirtieth birthday.

Baumbach was a key figure, not merely in many aerial campaigns, but in the fateful decision making that shaped Germany's desperate struggle against the combined forces of England, America, and the Soviet Union. In *The Life and Death of the Luftwaffe* he gives a detailed, frank, inside account of Germany's air war, seen from the top: Hitler as leader and strategist; the strengths and weaknesses of such Luftwaffe leaders as Goring, Milch, Udet, Jeschonnek, and Galland; the great controversies over strategy and tactics, fighters vs. bombers, that helped decide the war.

Baumbach tells of the visionary German weapons, many of which he tested himself, which laid the basis for modern war in the air – and in outer space: jet fighters, rockets, guided missiles, and the forerunners of today's "smart" bombs. He gives fascinating details of Luftwaffe plans which just missed being acted on: trans-Atlantic raids on New York City and the Panama Canal, the training of Germany's own Kamikaze (suicide pilots), and the incredible scheme for piggy-backing fighters and bombers to guide the unmanned bombers in on enemy targets, with devastating effect.

This book is required reading for all students of the German air force in World War II, and for everyone with an interest in War and Warriors.

## #199: **Heinz W. Schmidt: *With Rommel in the Desert***

No episode in desert warfare, from the wars of the pharaohs to Desert Storm, can match the 1942-1943 North African campaign for drama and romance. And its undisputed hero, even for his British enemies, was German General Erwin Rommel.

For nearly two years, outnumbered and undersupplied, General Rommel led the German forces of his celebrated Afrika Korps to one brilliant victory after another, until the balance of men and materiel (and the British and American ability to intercept and read his secret battle plans) overwhelmed the chivalrous "Desert Fox."

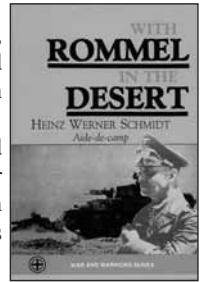
Heinz Werner Schmidt, Rommel's aide-de-camp, served at his commander's side from his first victories at El Agheila and Abedabia, in triumph at Tobruk and defeat before El Alamein, until the combined forces of Eisenhower and Montgomery overpowered the Afrika Korps at Tunis. His objective, detailed account of Rommel's desert campaign, written with dry humor and warm human sympathy for the soldiers of all sides, is a military classic.

Schmidt's *With Rommel in the Desert* dispenses with the larger-than-life Rommel of propaganda and legend to give us Rommel the officer and Rommel the man, confronting and meeting the challenges of a new kind of warfare in a unique and unforgiving environment. Schmidt puts his reader at Rommel's side, bending over the map in the Desert Fox's command tent, planning his next thrust at Tobruk or El Alamein, anticipating the next onslaught of British or American tanks and infantry.

Schmidt takes the reader bounding across the Libyan Desert in a Panzer outside Tobruk, dining on camel liver or fresh-shot gazelle in the wilds of the Libyan Desert, dodging rifle bullets or tank shells in dozens of engagements from Egypt to Tunisia. Its combination of strategic overview and combat excitement make *With Rommel in the Desert* unique among histories of the North African campaign.

*With Rommel in the Desert* is an important, first-person contribution to the history of an episode in modern warfare that will live on as long as heroism and chivalry in battle are honored.

### #203: **Hamilton Fish: *FDR. The Other Side of the Coin***

Hamilton Fish was one of those few former members of Congress who participated actively in the consideration of the early New Deal measures and in the dramatic pre-war debates of 1939-1941. His political experience included three years in the New York State Assembly and 25 years in Congress, ten as ranking minority member of the Foreign Affairs Committee and four in the same capacity on the Rules Committee. His firsthand experience places him in a unique position to write the history of our still almost-unknown involvement in WWII.

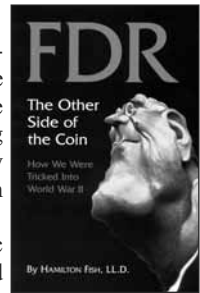
*The Other Side of the Coin* deals with the president's clandestine diplomatic negotiations in the dangerous months before American intervention in World War II: in the Danzig Crisis, with which Mr. Fish was deeply involved; the war ultimatum to Japan, kept secret even from Congress; and the unpublicized communications with Ambassador Bullitt and British leaders.

Mr. Fish felt that had FDR listened to public opinion, overwhelmingly against American intervention in every poll, Hitler would have attacked Soviet Russia, not Britain and France. He documents how FDR refused every prewar peace concession the Japanese offered, and later refused peace initiatives from the head of the German Secret Service – at a staggering cost in American lives and the lives of all European nations.

In his analysis of the geopolitical effects of the Yalta agreements, Mr. Fish traces the causes and roots of the Korean and Vietnamese wars to the territorial concessions given the communists at Yalta. The reader will also note disturbing parallels between the political steps which led to our involvement in World War II and those that preceded the Vietnamese debacle.

Above all, this provocative book is a plea for a return to the constitutional government envisioned by our Founding Fathers, with Congress having the sole right and power to declare war.

### #202: **William H. Chamberlin: *America's Second Crusade***

An award-winning journalist and historian of the Russian Revolution takes an early, critical look at the consequences of America's bent for self-righteous moralizing during and after World War II. A very useful survey from a resolutely American standpoint, although evidence unavailable to Chamberlin has since revealed corruption and criminality among America's war leadership undreamed of by the author.

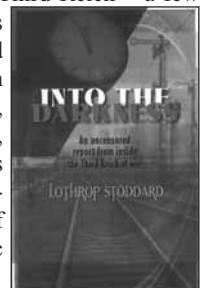


### #200: **Lothrop Stoddard: *Into the Darkness. A Report from Inside the Third Reich at War***

An objective reporter in Nazi Germany. There are many accounts of the Third Reich – a few favorable, many more hostile – by foreign journalists, but *Into the Darkness* is one of a kind. North American Newspaper Alliance reporter Lothrop Stoddard visited Germany in the fall of 1939, soon after Germany had gone to war with Poland, England, and France. After traveling widely in blacked-out Germany, talking to Germans from Hitler and Himmler to taxi drivers and chambermaids, Stoddard returned to America to write this unique report on the Third Reich as it actually was, not as its admirers or its detractors might have wished it. Stoddard's gimlet-eyed Yankee objectivity, coupled with his intimate knowledge of the country and keen sympathy for its people, makes *Into the Darkness* a classic account of National Socialist Germany.

Lothrop Stoddard was that rare combination, a scholar and a journalist. His Harvard doctoral thesis on Haiti's bloody slave revolt, published in 1914 as *The French Revolution in San Domingo*, signaled Stoddard's lifelong preoccupation with race and racial conflict. His best-selling *Rising Tide of Color* (1920) was influential in the reform of America's immigration law. Half a century after Stoddard's death in comparative obscurity in Washington, D.C., his prolific writings on the Western world's racial and political problems retain their relevance and their urgency.

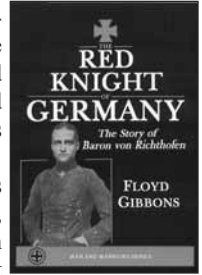

#195: **Floyd Gibbons: *The Red Knight of Germany. The Story of Baron von Richthofen***

The “Red Baron” has become an enduring and popular symbol of the devil-may-care aerial gallantry which ruled the skies of the Great War. This despite the roots of the real Red Baron, Freiherr Manfred von Richthofen, in the proud German Junker class, the enemy Americans learned to “love to hate” during and after the war. Floyd Gibbons’ classic biography, first published only nine years after the guns fell silent, reveals the man behind the myth. 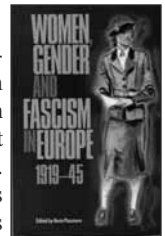

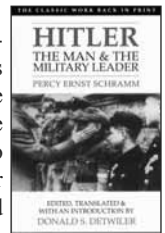

#189: **Alfred Rosenberg: *Political Essays***

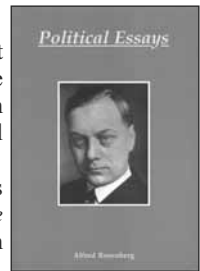
The National Socialist movement has been dismissed as a racist movement with no serious political philosophy. But one has only to read the writings of the NS chief ideologue Alfred Rosenberg to discover such a philosophy, especially in his principal work, *Der Mythos des zwanzigsten Jahrhunderts*, of what National Socialism sought to achieve through its doctrine of racial worth and power.

Rosenberg's youth was steeped in studies of the Nordic sagas and the works of Houston Stewart Chamberlain. It was Chamberlain's *Foundations of the Nineteenth Century*, which gave Rosenberg the inspiration to write his own major work.

When the NSDAP acquired full political power in 1933, Rosenberg was given nominal control of the Party's Foreign Policy Office. In 1934, he was appointed leader of ideological indoctrination and education. Only during the war, in 1941, did Rosenberg obtain a major political post as Minister for the Eastern Occupied Territories. At the end of the war, Rosenberg was arrested and tried at Nuremberg, where he was condemned to death by hanging on 15 October, 1946.

This book contains 22 essays by Rosenberg addressing various aspects of social, cultural, economic and political life. Selected and translated with an introduction by Alexander Jacobs.

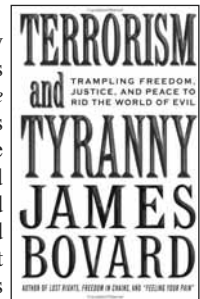

#164: **James Bovard: *Terrorism and Tyranny. Trampling Freedom, Justice, and Peace to Rid the World of Evil***

A devastating attack on President Bush's Justice Department and the similarly misnamed Patriot Act, *Terrorism and Tyranny* has been hailed by sources as disparate as the *Washington Post* and Pat Buchanan's *American Conservative* for its lucid and objective reporting. In 1992, German scholar Germar Rudolf gave several lectures before various academic societies in Germany. His topic was very controversial: the Holocaust in the light of new forensic findings. Even though Rudolf presented nothing less than full-fledged Holocaust revisionism to mainstream audiences, his arguments fell on fertile soil, because they were presented in a very sensitive and scholarly way. This book is an updated version of these lectures.

The book's style makes it a unique contribution to revisionist studies: It is a dialogue between the lecturer, who introduces the reader to the most important arguments and counter arguments of Holocaust revisionism – backed up with sources and references for further reading – and the reactions of the audiences to these presentations, which include supportive, skeptical, and hostile comments, questions, and assertions. *Lectures on the Holocaust* reads like a vivid and exciting real-life exchange between persons of various points of view, like a compendium of Frequently Asked Questions on the Holocaust and its critical re-examination. 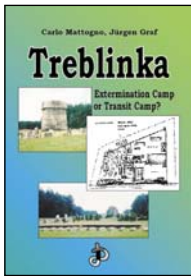

***Treblinka: Extermination Camp or Transit Camp?***

Holocaust survivors report that at least 700,000, and perhaps as many as 3 million people primarily of Jewish faith were murdered in the Treblinka camp, located in eastern Poland, between the summers of 1942 and 1943. Various murder weapons are claimed to have been used: mobile or stationary gas chambers; quicklime; hot steam; high voltage; machine guns; vacuum chambers; chlorine gas; Zyklon B; and diesel exhaust gas. According to the witnesses, the corpses of the victims were finally incinerated on pyres as high as a multi-story building without leaving any traces.

In the first part of *Treblinka*, the official account of the camp is subjected to a thorough critique of its historical genesis, inner logic, and technical feasibility. Mattogno and Graf's analysis reveals that the historical picture prescribed by penal law in many European countries is nothing more than an unbroken chain of absurdities. The second part of *Treblinka* reconstructs from painstaking analysis of the extant evidence Treblinka's actual function as a transit camp for Jews on route to other locations.

***Bełżec in Propaganda, Testimonies, Archeological Research, and History***

Witnesses report that at least 600,000, if not as many as three million people primarily of Jewish faith, were murdered in the Bełżec camp, located in eastern Poland, between November 1941 and December 1942. Various murder weapons are claimed to have been used: diesel gas chambers; quicklime in trains; high voltage; vacuum chambers. According to witnesses, the corpses were finally incinerated on huge pyres without leaving any traces.

For those who know the stories about Treblinka, this all sounds too familiar. The author has therefore restricted this study to aspects, which are different and new compared to Treblinka, but otherwise refers the reader to his Treblinka book. The development of the official image portrait of Bełżec is explained and subjected to a thorough critique. In contrast to Treblinka, forensic drillings and excavations were performed in the late 1990s in Bełżec, the results of which are explained and critically reviewed. These findings, together with the absurd claims by 'witnesses,' refute the thesis of an extermination camp.

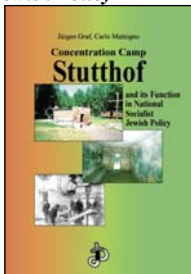


## Item No. 49: Jürgen Graf, Carlo Mattogno

### *Concentration Camp Stutthof and its Function in NS Jewish Policy*

The NS concentration camp of Stutthof (West Prussia) has never been the subject of scientific study by western historians. Heretofore only Polish communist writings, to be treated with caution, have dealt with Stutthof. According to this literature, Stutthof became a 'makeshift' extermination camp within the so-called 'Final Solution of the Jewish Question' in 1944.

Jürgen Graf and Carlo Mattogno have examined this view of Stutthof based on Polish literature and documents located in Russian, Polish, and Dutch archives, paying particular attention to mass transports to and from Stutthof in 1944. The authors prove that the Stutthof camp did not serve as a "makeshift" or any other kind of extermination camp, but that the room claimed to have been used as a homicidal gas chamber was never anything else but a delousing chamber. *Concentration Camp Stutthof* also sheds some light on the fate of those prisoners who were deported to Auschwitz but were never registered in that camp. This is a milestone of research, that no serious historian can afford to ignore.



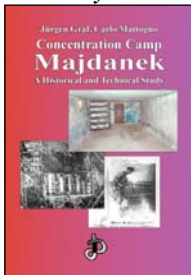

### *Concentration Camp Majdanek. A Historical and Technical Study*

Little scientific investigation has been directed toward the camp Lublin-Majdanek in central Poland, even though orthodox Holocaust sources claim that between 50,000 and over a million Jews were murdered there. Until the appearance of *Concentration Camp Majdanek*, the only works on Majdanek were authored by historians serving or trained under Poland's communist regime.

Mattogno and Graf have filled this glaring research gap with a monumental study that expertly dissects and repudiates the myth of homicidal gas chambers at Majdanek. Contrary to conventional views, Rigg reveals that during WWII a startlingly large number of individuals, who were classified by Germany's government as Jews or "partial-Jews" (*Mischlinge*), served loyally in the German army. 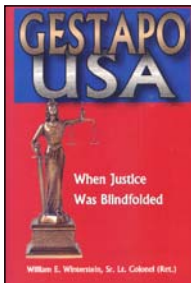

Arthur Rudolph, a German rocket engineer brought to this country after World War II, played a key role in the program that enabled his adopted country to land on the moon in 1969. *Gestapo USA* tells the story of how, long after Rudolph had been cleared of any wrongdoing for his wartime role in supervising forced laborers manufacturing V2 missiles, he was stalked, ambushed, and driven from the United States by lawyers working for the Office of Special Investigations. 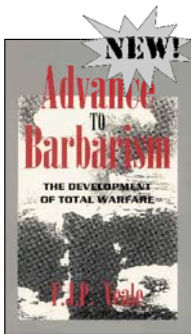

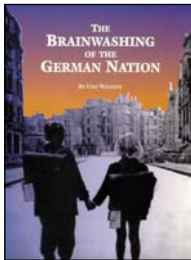

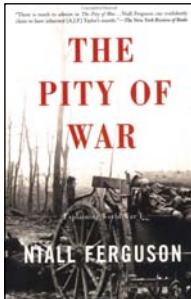

Niall Ferguson, a distinguished Oxford scholar, makes a simple and provocative argument: that the human atrocity known as the Great War (WWI) was entirely England's fault. ***The Last Days of the Romanovs. How Tsar Nicholas II and Russia's Imperial Family Were Murdered***

Robert Wilton’s study of the grisly murders of Tsar Nicholas II and his family by Jewish Bolsheviks in a cellar in Ekaterinburg, Siberia, July 16-17, 1918, is still the most riveting account of a crime that, in its brutal slaughter of the saintly Nicholas, his consort Alexandra, their five young children, court physician, and three loyal servants foreshadowed the horrors of Communism in grisly detail. 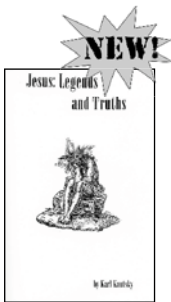

*The Passion of Jesus Christ* is based entirely upon the Gospels, but Kautsky claims that they misinterpret Jesus. 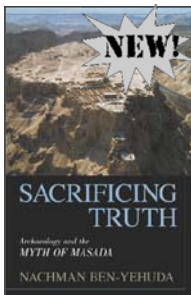
According to a patriotic legend still current in Israel, in 73 A.D. 960 Jewish rebels committed suicide at the fortress of Masada rather than surrender to Roman forces, but do the facts uncovered at Masada by archaeologists actually support the legend? Ben-Yehuda closely examines the daily transcripts of the archaeologists' conversations at Masada.
